THIS MATTER having come before the Magistrate on April 16, 2025, and having heard the testimony and other evidence of the parties, and having been fully apprised of the circumstances, and based upon a preponderance of the evidence, does find as follows:

1. This Fine Reduction Stipulation and Agreed Recommended Order involves a parcel located at 8004 SE Carlton Street, HOBE SOUND, FL 33455, Martin County, Florida and further described as:

Lot 70, HOBE SOUND ESTATES, according to the map or plat thereof as recorded in Plat Book 4, Page 13, Public Records of Martin County, Florida.

- 2. On June 21, 2023, an Order Finding Violation was issued by the Code Enforcement Magistrate to CHITTY LISA M BISHOP CHRIS, for the following violation(s):
 - Section 67.201.A Weeds Nuisance Declared: Weeds, Undergrowth General Ordinances, Martin County Code

Compliance was required by July 31, 2023. On, an Affidavit of Compliance/Accrued Fines was issued reflecting an outstanding fine of \$40,100.00 plus costs in the amount of \$575.00.

- 3. Staff has determined that a lien reduction is warranted. Respondents were responsible for the violation; and, they brought the property into compliance and have offered to pay \$ 4,067.50 to resolve the outstanding fines which have accrued.
- 4. The parties represent, under penalty of perjury that that they have read this Stipulation; that they have full authority to enter into this Stipulation; that the facts contained herein are the truth, the whole truth and nothing but the truth; and that they are signing this agreement freely and voluntarily and are under no duress to execute it.
