Assistant Village Manager/ Director of Engineering and Environmental Services

The Village of Wellington was a relatively new incorporated municipality in the West Palm Beach, Florida metropolitan area. Wellington's permanent population grew from approximately 25,000 in 1996 to approximately 65,000 (plus seasonal residents of roughly 10,000) in 2007 and had been the fastest growing municipality in Palm Beach County. Palm Beach County currently has a population of over 1.4 million. Wellington is a diverse bedroom community as well as the home of a world class equestrian community including polo and show facilities.

DUTIES/RESPONSIBILITIES

- Serve as Acting Village Manager in absence of Village Manager
- Director of Engineering & Environmental Services providing comprehensive engineering, public works, utility and solid waste municipal services with approximately 140 employees in direct chain of command and a \$40+ million operating budget, including a nearly 22,000 customer water and wastewater utility system as well as two special districts which are responsible for surface water management systems covering over 42 square miles and over 25,000 customers.
- Served as Emergency Management Director in all declared emergencies, including 5 major hurricanes within less than 2 years. I was given complete transfer of power from the Village Manager in declared state of emergencies. I was fully responsible for all business, restoration, field operations, logistics, safety and communications activities and functions during declared emergencies including all police and fire operations and all financial, safety and security measures at all times.

- Re-organized various departments into Department of Environmental and Engineering Services consisting of Public Works (Landscaping, Building Maintenance, Roads, Fleet Maintenance and Surface Water Management Divisions), Utilities (Field Services, Customer Service, Utilities Maintenance, Water Treatment Facility and Wastewater Treatment Facility Divisions) Solid Waste (Contract Administration, Customer Service and Operations Divisions), Environmental (Laboratory, Mosquito Control and Environmental Code Compliance Divisions), Engineering (GIS, Land Development and Capital Projects Divisions) and also Parks and Recreation (Facility Maintenance and Neighborhood Parks) and the remainder of Parks and Recreation as necessary from time to time.

Waste Collection and Recycling

- Researched, developed and recommended a comprehensive strategy based on state and federal laws pertaining to the preservation of the Everglades (compliance with the Everglade's Forever Act) including:
 - Creation of "Surface Water Action Team (SWAT)" to meet statutory deadline for stormwater discharge into the Everglades by December, 2006. This project was estimated to cost approximately \$20 to \$30 million. The proposed strategy, while for a regional environmental problem, mitigated a major pollution problem palced on the Village to resolve.
 - Identified funding mechanisms, evaluated necessary land acquisition, adopted best management practices involving fertilizer controls and horse waste containment, addressed stormwater pollution standards, established project cost projections and studied economic impact on the Village's equestrian industry.
 - Presentations to state legislative committees, the South Florida Water Management District Board, the Village Council and various Boards and Committees.
 - Coordinated submittal and receipt of multi-million dollars of grants for various Village projects

City of Plantation, Florida

The City of Plantation has a population of approximately 68,000. The City of Plantation is located in the Fort Lauderdale, Florida Metropolitan Statistical Area with a total population of approximately 1.5 million.
