 - ii. Tax / control issue (tiers of recognition / designation)
 - b. Update historic sites survey
 - c. Support Martin County staff efforts to identify and apply for appropriate grants to help fund restoration of County owned historical structures
 - d. Interlocal agreements
 - e. Send letter to owners of properties 50 years and older
