

**RESOLUTION NUMBER**

**WHEREAS,** The Florida Department of Environmental Protection (FDEP) is providing \$1,807,000 funding assistance to Martin County for grant agreement 24SRP08 to include engineering design, regulatory permit applications, bidding and construction to support the elevation of the roadway, installation of a weir structure with check valve discharge and installation of ancillary drainage to support adaptation and mitigate flooding; and

**WHEREAS,** Martin County is required to provide a local match of \$1,807,000 through cash or third party in-kind towards the work funded under this agreement; and

**NOW, THEREFORE, BE IT RESOLVED,** BY THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY, FLORIDA, THAT THESE REVENUES AND APPROPRIATIONS BE ADDED TO THE BUDGET AS FOLLOWS:
