S. Maragh – If the County produced the agenda and sent it over to you, we have those records, and it will not need to be forwarded back to the County. If you then send the agenda to someone else that will need to be forwarded to Noehmi.


- S. Tsafarides – Can you send the email information regarding the financials and emails again?
