Construction Engineering Inspection Services and Construction of a 10' multimodal path will connect to existing bicycle lanes on the north and south side of SE Monterey Road and to the existing sidewalk on the north side of SE Monterey Road, as well as to the existing lane on SE Palm Beach Road at SE 16th Court. Also, the following items to be included.

- Replacement of the sidewalk on SE Dixie Hwy to extend it to a 10' wide multimodal path.
- Reconfigure existing drainage ditches
- Install streetlight poles and utilities.
- Install crosswalks
- Install pavement striping
- Install signage
- Install signals

Reason for Supplement and supporting engineering and/or cost analysis:

This supplemental agreement reconciles the LAP Agreement total project cost with the Department's concurrence and Local Agency construction bid award.
