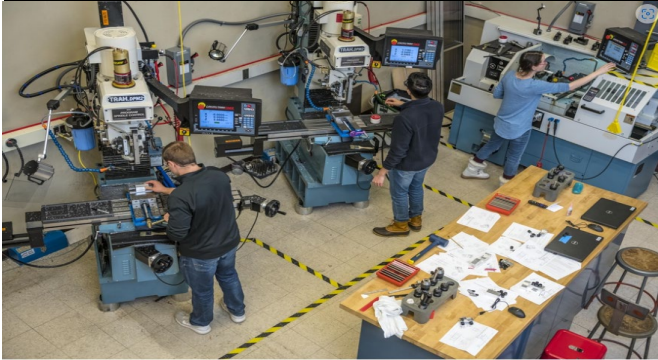

DESCRIPTION

ARPA funds will be used to renovate Building 17 at the Airport to provide the County with a workforce transition center. The building will be used to train a workforce to meet the demands of the Martin County economy. This building will initially focus on legacy and targeted industries in Martin County. The REACH center will also allow for based industries to collaborate and upskill existing employees.

BACKGROUND

The REACH Center is being constructed to address Martin County workforce issues that were identified by the COVID-19 Economic Impact Study of 2021. The REACH Center will allow for the quick transition of workforce from one sector to another, but focusing on legacy industries like Aviation and Marine. The REACH Center will increase Martin County and Witham Field's resilience to economic downturns.
