WHEREAS, The Seaside Café at Stuart Beach is expected to begin operating in October 2020 and an operational budget must be established in order to commence operating; and


WHEREAS, Unanticipated funds must be appropriated in accordance with Section 129.06(2)(d), Fla. Stat., and
