

Airport Noise Advisory Committee

Created Pursuant to Resolutions 03-8.22, 05-2.20, 05-9.2, 08-2.34, 11-4.24, 11-7.2, 16-7.15, and 25-7.2

Powers & Duties: The Committee was created pursuant to the recommendation of the Part 150 Noise Study Planning Advisory Team. The Committee shall have the duty and responsibility to make recommendations to the Board of County Commissioners concerning the implementation of the operational and land use mitigation measures adopted in the Federal Aviation Regulation Part 150 Study.

How Appointed: The Committee shall be comprised of 13 members. Each member shall be a Martin County resident or business owner of an aviation related business located at Witham Field. Membership is as follows:

- Four members be residents residing within a two-statute mile radius of Witham Field (changed 7/26/16 & increased to four 7/8/25)
- Aircraft Owner who has Aircraft Based at Witham Field
- Representative from a Witham Field Based Flight School
- Representative from a Fixed Base Operator at Witham Field
- Representative from a Charter Operator Based at Witham Field
- Sewall's Point Representative from the Town Council
- City of Stuart Representative
- Representative from an Industry Trade Group or an Airport Tenant (added 7/8/25)
- Witham Aero Club (added 2/26/08)
- A County Commissioner

Terms: The Committee shall be in existence until all Part 150 Study recommendations are implemented by the Board of County Commissioners or until such time as the Board of County Commissioners sunsets the Committee.

Meetings: As needed to develop and implement the Recommendations of the FAA Part 150 Study.
