# Agenda Item: 25-0134, Rio CRA Architectural Design Guidelines

Jessica Seymour, Principal Program Coordinator of the Treasure Coast Regional Planning Council presented the updated proposed CRA Architectural Design Standards for the Rio CRA. This effort has been undertaken to update and codify the design standards for clarity and predictability of use by architects, builders, property owners and staff, and to continue to implement the vision of well-designed communities that celebrate their distinctive identities and contribute to the overall sustainability of Martin County.

- R. Kennedy This is the best presentation I have heard so far on this process. Thank you for the clarity.
- M. Readling How does the building actitivy outside of the CRA relate to these design standards?
- J. Seymour As far as I know, unicorporated Martin County does not follow any architectural standards for residential, but there are commercial design standards.
- J. Lopilato I would like to see all 11 architectual designs available to Rio in the CRA. This creates more diversity and allows flexibility.
- M. Readling I agree, this is what makes Rio unique, allowing all of the styles.
- J. Newhart What if someone buys a historic house, can they knock it down?
- J. Pastorius Explained the process of designating historic homes in Martin County.
- J. Preast We only have one historically designated home in Rio located on Glass Dr.
- D. Legler Are these new standards required or is it a recommendation? It feels like you are putting these standards forward and requiring custom home type builds and it will be more expensive.
- J. Seymour We are trying to be cognizant of the cost for the suggested elements while allowing a great degree of flexibility.
- J. Gregory I feel like you are now requiring an extra layer of work for building permits in Martin County.
- J. Seymour Not at all, every home will have a front door, a roof, etc and we are defining how to apply these certain designs, Florida Vernacular just as an example. This is not requiring more expensive doors for example, just how you put the pieces together.

- S. Maragh These are not public records.
