IV. Agenda Items

A. County Capital Improvement Projects

Martin County Senior Project Engineer Keith Baker presented Martin County's Capital Improvement Projects. He highlighted Coral Gardens and Leilani Heights neighborhood restoration projects, roadway and sidewalk construction, and bridge project updates.

Traffic Engineering Administrator Luke Lambert presented updates on Martin County traffic projects.

Environmental Resource Administrator John Maehl provided updates on various environmental resource projects.

School Board Member Michael DiTerlizzi thanked the County for their work on the Delaplane Peninsula ingress.

School Board Member Amy Pritchett inquired about the Twin Rivers stabilization project. Mr. Maehl briefly explained the projects purpose is to address an erosion issue.

B. City Utilities and Engineering Projects

City of Stuart Engineering and Utilities Director Peter Kunen provided the City of Stuart's transportation, stormwater and facility project updates.

School Board Member Masha Powers asked for updates on Palm City Road planning. Mr. Kunen advised the plans are currently in review with FDOT.

Commissioner Smith commended the contractors for doing a great job with Wright Boulevard.

C. Village Capital Projects Update

Village of Indiantown Utilities and Public Works Director Patrick Nolan presented the Village's public works, water, and special projects updates.

D. County / City / Village City Development Update

Growth Management Principal Planner Samantha Lovelady provided updates on the County's growth. She stated the City of Stuart does not have any approvals at this time.

Village of Indiantown Community Development Director Deanna Freeman provided development review and approval updates. Village Manager Taryn Kryzda assisted with questions.

Commissioner Eula Clarke suggested providing an overview of the Village's boundaries.

Ms. Freeman shared with the Boards, that the Village of Indiantown received grant funding to conduct data analysis regarding population growth.

Commissioner Clarke inquired on the status of mass transportation (i.e. Marty or van services), to route people from the Village to the East Coast. Village Manager Taryn Kryzda stated the Village increased Marty program funding to assist with rider-ship increases.

The Boards further discussed mass transportation and the economic advantages it will provide.

E. School District Update

Martin County School District Deputy Superintendent Dr. Tracey Miller presented school enrollment and control open enrollment updates. Director of Facilities Mark Sechrist presented the facilities updates.

The Board members discussed open enrollment and the need for expansion to aid with population growth. The Boards further discussed funding and the impact of charter schools on the District.
