The Bahamian Festival is scheduled for October 4. She hopes that will not conflict with construction of New Monrovia Park.

- G. Ehrler I hope you recommend this alternative compliance request.

## Agenda Item: 25-0639 - FY2026 CAPITAL IMPROVEMENT PLAN

Joy Puerta, CRA Program Manager, provided a presentation on the Port Salerno CIP, which included an explanation of what the CIP is, how TIF works, current projects, potential projects and went through each of the staff's funding recommendations.

- C. Cass I don't remember SE Georges Way in the Park Drive project. We agreed to put money into septic to sewer. Part of my concern is that we want to improve New Monrovia. Why is it so difficult for us to get sewer. He asked for the specific number for the septic to sewer project. What are the chances that the grant will happen?
- J. Puerta I have meeting minutes and a slide from a previous CIP that shows SE Georges Way
  was approved to be in the project.

The other committee members present also confirmed that they approved it.

- S. Kores There is no way for us to know if the grant will come through or not. Utilities is the
  Department that is handling that. There are many variables that affect any grant, how much
  money is there to begin with, how many others have applied, how much have they applied for,
  do they have a greater need, etc. It is the federal government and its agencies that will make
  that determination, we don't have any control over what the decision is or the timing of that
  decision.
- M. Warden Can we get Mr. Repetti back to talk to us about Park Drive and the whole project on the peninsula?
- S. Kores We will invite Utilities and Public Works to the next meeting.

- E. Asselin This is sewer for all of Port Salerno, not just New Monrovia. Are we not included?
- J. Puerta Martin County Capital Projects has three sets of project plans for the area. Port Salerno North (north of Salerno), Port Salerno South (between Salerno Rd and Cove Rd) and New Monrovia (south of Cove Rd).
- B. Olsen I feel like staff recommendations are really in line with New Monrovia improvements and the improvements already approved and I fully support staff's recommendations.
- T. Anderson I will bring some perspective and clarity and tell you exactly what the situation is.
  He talked about the history of New Monrovia and the years of public neglect of infrastructure that
  should have been installed years ago. People don't have the money for the sewer.
- C. Smith We had to pay for the roads in Dixie Park, give us paved roads in New Monrovia. She would like to revisit Habitat for Humanity and the money they had for roof repair. We heard about the sewer grant in 2024, let's get this done.
- G. Ehrler I'd like to look at the Dixie Park slide again. Are we looking for 6-foot sidewalks? This is a public ROW, correct? And staff recommend \$100,000 towards that project?
- J. Puerta Yes.
- S. English I am confused, when did the sewer project become three projects? MC said the
  project will be done for the whole area and our cost will be \$5,000 each. What happened to that?
- J. Puerta That's what the plans show.
- J. Rolle The pipes that are there are for other parts of the county. We can't tap into what is there, and those are at capacity.
- C. Cass Infrastructure Partnerships please describe the \$600,000.
- J. Puerta That is the funding for the Park Drive Improvements, already approved, added there
  so that we can be sure to continue to have \$4 million for sewer when we need it.

## OLD BUSINESS

Agenda Item: 25-0640 - PROJECT UPDATES

J. Puerta, Community Development Program Manager, updated the community on the following projects: unpaved roadways, New Monrovia lighting, Mew Monrovia Park, Dixie Highway crosswalks, New Monrovia neighborhood improvements and speed control.

Miscellaneous news: The downed electric pole is finally removed. Mooring field facility is going up quickly, it already has walls. The call for artists for the mosaic have gone out. We did include pictures of the New Monrovia signage and the Request for Service tips in the Community Pulse as requested and there is a quick public art survey we invite you to do.

Don't get railroaded by the commissioners or other policies.
- J. Rolle I do appreciate everyone showing, it is important. Let's get the emails and calls going to the Legislature to get the grant.
