**RESOLUTION NUMBER 25-**

**[REGARDING A CHANGE IN ZONING CLASSIFICATION FROM  
PUD-C, PLANNED UNIT DEVELOPMENT-COMMERCIAL DISTRICT  
TO GC, GENERAL COMMERCIAL DISTRICT  
FOR DRIVEN BRANDS, INC.  
WITH A CERTIFICATE OF PUBLIC FACILITIES EXEMPTION]**

**WHEREAS**, this Board has made the following determinations of fact:

1. Driven Brands, Inc., submitted an application for a change in zoning district classification from the current Kanner Square Planned Unit Development (PUD) Zoning Agreement to GC, General Commercial District, for the property described in Exhibit A, attached.
2. The Local Planning Agency (LPA) considered the application at a properly noticed public hearing on June 5, 2025. The LPA's recommendations were forwarded to the Board of County Commissioners (Board) for consideration.
3. This Board has considered such recommendations.
4. Upon proper notice, this Board considered approval at a public hearing on the application on June 17, 2025.
5. At the public hearings, all interested parties were given an opportunity to be heard.
6. All conditions precedent to granting the change in zoning district classification have been met.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY  
COMMISSIONERS OF MARTIN COUNTY, FLORIDA, THAT:**

- A. The Kanner Square PUD Zoning Agreement is hereby terminated.
- B. The zoning district classification of the property described in Exhibit A is hereby changed from the Kanner Square PUD Zoning Agreement to GC, General Commercial District.

C. Pursuant to Section 5.32.B.3.f., Land Development Regulations, Martin County Code, this rezoning action is hereby determined to meet the requirements for a Certificate of Public Facilities Exemption.

D. Pursuant to Section 14.1C.5.(2), Comprehensive Growth Management Plan, Martin County Code, regarding preliminary development approvals, the property described in Exhibit A is subject to a determination of level of service capacity at final site plan approval and no rights to obtain final development orders, nor any other rights to develop the subject property have been granted or implied by this Board.

E. This resolution shall be recorded in the public records of Martin County. A copy of this resolution shall be forwarded to the applicant(s) by the Growth Management Department subsequent to recording.
