PRESENTATION

Agenda Item: 25-0779, Hobe Sound NAC – Minor Final Site Plan Presentation - Wisteria Place Dan Siemsen, Principal for 2GHO, presented the concept of a Minor Final Site Plan Application for a 17-unit townhouse development in the Hobe Sound CRA area. The applicant Steve Thompson was also present.

- M. Miller Has this project gone to the County?
- J. Cox This has recently been submitted to the Growth Management Department.
- R. Krebs Has the drainage plan been reviewed?
- D. Siemsen We will be working on it with Martin County, but all the discharges will be held on-site and go to the dry retention area west of the property.
- E. Thorsen Will the homes have balconies? Please use native planting and keep any trees you can.
- D. Siemsen None will have balconies.
- R. Krebs Will the shrub area be left?
- D. Siemsen Yes it will be preserved.
- M. Mathews I live near this area, and we were not notified. I like that these homes have garages, but what about overflow parking?
- D. Siemsen There will be guest parking on the property.
- M. Mathews These two-story homes are great, but not the best place for the area. There will be a lot of noise produced especially with the clubhouse pool. I am strongly objecting to this project. I would like to see this somewhere else. Has there been a water development study done for this? I am worried I must dig deeper for my well.
- J. Sinnott We will be reaching out to South Martin Region Utility about the study.
- R. Krebs Ms. Mathews, the developer demonstrates on their plan that the discharge water will stay onsite which will go back underground.
- B. Capps Some private roads like Gold Avenue are dirt roads that you'll be using once it goes into construction. This will cause stress on the roads. What will you be doing about that?
- E. Thorsen Will you be able to pave Gold Avenue as part of the project? As for the pool noise perhaps, there could be pool rules. What is the targeted home cost?
- D. Siemsen We will investigate what could be done for Gold Avenue. These homes are for middle-class homeowners.
- C. Weisleder This project could improve property value.
- M. Gavin What kind of notices will there be for the nearby neighborhood?
- J. Sinnott There will be a yellow sign that has the permit number on the property during the process.
- M. Miller This looks like a great project and the applicant has been going by all CRA guidelines.
- M. Gavin Take a look at Tradewinds in Hobe Sound they did a great job. I would recommend adding landscape to the houses all the way up.
- D. Siemsen Thank you, we could add more.
