Became secretary, and lifetime Member, working on the Friends of the Morgade Library, before the library was even built, until such time as the Martin County combined Friends Group formed this year.

Worked on every Salerno Seafood Festival, except one, due to the care of my husband, who had Alzheimer's.

Spent over 10 yr. with Alzheimer's support group.

Currently, volunteer greeter at Coastal Life Church, Stuart, located on A1A.

Volunteering at Council of Aging at the Kane Center, working in the kitchen with Meals on Wheels, where we also do benefits for Meals on Wheels, Adult Day Club and Alzheimer's symposiums.
