**RESOLUTION INCREASING THE FIND, MANATEE PARK SEAWALL RESTORATION GRANT REVENUES AND APPROPRIATIONS**

- WHEREAS,** The Florida Inland Navigation District (FIND) has issued contract MA-25-100 to fund the Manatee Park Seawall Restoration project; and
- WHEREAS,** FIND will contribute no more than fifty percent (50%) or up to \$350,000; and
- WHEREAS,** A fifty percent (50%) or up to \$350,000 match is required; and
- WHEREAS,** Unanticipated funds must be appropriated in accordance with Section 129.06(2)(d), F.S.;
