PRESENTATIONS

Agenda Item: 25-0199 – CRA Port Salerno Architectural Design Standards

Dana Little, Urban Design Director and Jessica Seymour, Principal Program Coordinator of the Treasure Coast Regional Planning Council will present the updated proposed CRA Architectural Design Standards for all six Martin County CRA areas. This effort has been undertaken to update and codify the design standards for clarity and predictability of use by architects, builders, property owners and staff, and to continue to implement the vision of well-designed communities that celebrate their distinctive identities and contribute to the overall sustainability of Martin County.

R. Kennedy – Where you able to go to all the NACs (Neighborhood Advisory Committee)? I know some had to be rescheduled because of the hurricane.

D. Little – Yes, we have presented to all the NACs. It was a good to see each NAC tailor what styles they liked for their CRA.

M. Reading – Rio didn't want any styles from the list, we wanted to include any style and not be subject to a list. Why are we limiting applicants when the CRA makes up 1% of the county when you can go outside the CRA, and you can build whatever you want? This doesn't make sense to me and some of these styles will price people out if they are trying to build. This is turning us into an HOA.

D. Little – If you can think of any other architectural styles that are universally recognized, please let us know. The Contemporary style is our catch-all style that is included for any of the areas to choose. We were not intentionally limiting any applicants as we made sure to include all styles.

S. Kores – Based on our statute, CRAs were made to reduce or eliminate slum and blight. One of the ways to do this is to raise the bar by the rehabilitation of new, current, and old structures. The updates to the Architectural Design Standards will add more flexibility for applicants to choose from compared to the limitations of the current code.

J. Pastorius – At the last Rio NAC meeting, it was a unanimous vote to approve all styles presented.

R. Sentell – I don't like houses to look all the same, but this allows flexibility with its own identity for each CRA.

B. Krebs – Hobe Sound went with all the styles except for Ranch. It was too broad of a style for our CRA. The rest of the styles from the list will still allow flexibility.

D. Braden – I appreciate what everyone wants to accomplish with the Architectural Design Standards. You say this will keep costs down, but in the current code we have to have a 21-inches from the finished grade to the finished floor and there is no benefit to it. The Main Street Vernacular code has to be 12 ft. ceilings on the first floor and that makes no sense. It will cost more to build and maintain. Churches should be exempted from the CRAs.

G. Ehrler – I agree we should not be limiting our possibilities. Can the description for each style's text change from 4 stories to 3 stories and make it consistent with our codes? What is the appeal process if an applicant doesn't want to go with any of the styles?

C. Cass – Mr. Braden has been going back and forth with the County staff about this. Now staff has been told to stop addressing it with him.

S. Poprawski – We have reviewed Mr. Braden's documentation and do not find any ADA violations for the 21-inch requirement. We do have Alternative Compliance available for those who cannot follow the current code.

R. Krebs – Are there some companies local that do this style?

S. Kores – I know some companies from South Florida that use this method, but they also work here in Martin County on some projects.


