PERMISSION TO APPLY

1. Permission to Apply for the Gary Sinise Foundation Grant for Equipment

- Requestor Fire Rescue Department
- **Granting Agency –** Gary Sinise Foundation
- <u>Project Description</u> Martin County proposes to replace aging gym equipment in multiple stations with the help of grant funding provided by the Gary Sinise Foundation. Physical fitness is a critical component in the health of all employees. Funding from this grant program will provide upgraded equipment that will support wellness initiatives and functional fitness to support job performance.
- Requested Grant Award \$26,653
- Budgetary Impact There is no grant match requirement.
- Annual operating costs Staff time to administer the grant.

Alternative Action:

- <u>Programmatic Implication if not approved</u> Lack of grant funding will extend the replacement schedule for aging equipment.
- <u>Financial Fiscal impact if not approved</u> Utilize limited budget resources to replace equipment when possible.

2. <u>Permission to Apply for the Hazard Mitigation Grant Program (HMGP) for Federal Emergency Management Agency (FEMA) 4834-DR-FL, Hurricane Milton for Fire Station Bay Door Replacement</u>

- Requestor Fire Rescue Department
- **Granting Agency** Florida Division of Emergency Management (FDEM)
- <u>Project Description</u> Martin County proposes to replace overhead mechanical
 fire station bay doors with bi-fold lateral operating doors. Overhead mechanical
 doors are unreliable, costly to maintain, and open at a slow pace. The bi-fold
 doors allow for rapid egress, lower maintenance, and safer operations. This
 project is currently funded in the FY25 adopted Capital Improvement Plan (CIP).
 This grant funding would significantly reduce the ad valorem needed to complete
 the project and allow the remaining budget to be redirected to other CIP priorities.
- Requested Grant Award \$1,474,200
- <u>Budgetary Impact</u> A \$368,550 (25%) grant match, which is budgeted in the Fire Station Bay Door Replacement Program CIP sheet.
- Annual operating costs Staff time to administer the grant.

Alternative Action:

- <u>Programmatic Implication if not approved</u> The project will move forward with current CIP approved funding.
- <u>Financial Fiscal impact if not approved</u> A reduction in ad valorem funding needed to complete the project would not be realized.

3. <u>Permission to Apply for the Hazard Mitigation Grant Program (HMGP) for Federal Emergency Management Agency (FEMA) 4834-DR-FL, Hurricane Milton</u>

- Requestor Utilities & Solid Waste Department
- **Granting Agency** Florida Division of Emergency Management (FDEM)
- <u>Project Description</u> Martin County proposes to replace generators at master lift stations with fixed bypass pumps. The bypass pump does not rely on the lift station electrical panel, which has a chance of becoming damaged in a storm. The fixed bypass pump is more reliable to prevent sewer overflow events due to an interruption in the electrical power supply in comparison to a generator. The bypass pump is more fuel efficient because it does not continuously run like a generator does. This results in fuel cost savings. This project consists of 8 bypass pumps for Martin County owned lift stations.
- Requested Grant Award \$399,102
- <u>Budgetary Impact</u> A \$133,034 (25%) grant match, which is budgeted in the Utilities and Solid Waste Capital Improvement Plan (CIP).
- Annual operating costs Staff time to administer the grant.

Alternative Action:

- <u>Programmatic Implication if not approved</u> Lack of grant funding will impact the acceleration of projects to increase environmental protection and disaster mitigation.
- <u>Financial Fiscal impact if not approved</u> Utilize CIP funds or seek alternative funding.
