NON-EXCLUSIVE FLOW-THROUGH DRAINAGE EASEMENT

THIS NON-EXCLUSIVE FLOW-THROUGH DRAINAGE EASEMENT, granted and executed this _____ day of _____, 2025, by **MARTIN COUNTY**, a political subdivision of the State of Florida, whose address is 2401 S.E. Monterey Road, Stuart, Florida 34996, Grantor, to **MEDALIST BUILDING GROUP, LLC**, a Florida limited liability company, whose mailing address is 1235 SW 34th Street, Palm City, FL 34990, Grantee.

(Wherever used herein the terms "Grantor" and "Grantee" shall include singular and plural, heirs, legal representatives, and assigns of individuals, and the successors and assigns of corporations, wherever the context so admits or requires.)

WITNESSETH that the Grantor, for and in consideration of the sum of \$1.00 in hand paid by the Grantee, the receipt and sufficiency of which is hereby acknowledged, does hereby grant unto the Grantee forever, a perpetual non-exclusive flow-through drainage and access easement on, over, under, across and through the land described and depicted on Exhibit "A" attached hereto and made a part hereof (the "Flow-Through Premises") to ensure the free flow of water for general public drainage purposes, over, through and under the Flow-Through Premises, and for repair, installation, and use of a surface and sub-surface drainage system, and the repair, maintenance, replacement thereof, and for ingress and egress across, over, and upon the Flow-Through Premises as may be reasonably necessary, to carry out the purposes of this easement.

It shall be the obligation of the Grantee, and its successors and assigns, to repair, maintain and replace the drainage system within the Flow-Through Premises. Any alteration of the drainage facilities other than maintenance will require prior written authorization from the Grantor.

Grantor hereby covenants with Grantee that Grantor is lawfully seized of said land in fee simple, that Grantor has good and lawful authority to grant and convey this Easement, and that Grantor fully warrants the title to said land, and will defend the same against the lawful claims of all persons whomsoever.
