## **PRESENTATIONS**

### **Agenda Item: 24-1135, Hobe Sound Village Duplexes – Minor Final Site Plan**

Michael Houston, President of HJA Design Studio presented the committee the Hobe Sound Village Duplexes that consist of eight duplex buildings with a total of sixteen single-family units on approximately 2.15 undeveloped acres located south of SE Mars Street, North of SE Neptune Street, and approximately 260 feet west of SE Federal Highway.

E. Thorsen – Will lighting and sidewalk be included in this project?

M. Houston – Yes, those elements are included.

C. Nelson – Do any of the homes have garages?

M. Houston – Yes, some units have a 2 or 1-door garage.

B. Krebs – This seems like too many houses on a small parcel. I would like to see more landscape and if possible, get a retention pond for this area.

R. Sexner-Cole – This project is by the Banner Lake community and will increase their property taxes has it been brought up to the community?

E. Thorsen – It would be a good idea to do some sort of outreach for the Banner Lake community so they are aware of the upcoming project.

J. Cox – We will look into doing some outreach for the Banner Lake Community if this project moves down the path of approval with Growth Management

R. Sexner-Cole – After the project is completed who will be responsible for the maintenance of the vegetation around the homes?

M. Houston – Once the homes are purchased the new homeowners will be responsible for maintaining it.

B. McLaughlin – When there is rainfall where is the water going? Has it been addressed?

J. Sinnott – This project is still under review and will be required to follow Martin County stormwater standards and will be reviewed by all departments including Public Works.

F. D'Ambra – If the property owners of this parcel own the south and north areas, why are they not showing us the concepts for those lots too?

E. Thorsen –A Gopher tortoise would be nice as one of the wildlife pictures.


