**PRESENTATION**

**Agenda Item: 25-0054, Hobe Sound NAC – Access to the Arts - MartinArts**

Tori Hill, MartinArts Administrative Coordinator along with Chandler Josie provided a brief presentation on the Access to the Arts Program. The program’s objective is to enhance arts programming and outreach within underserved communities in Martin County, i.e., those facing economic challenges, people with physical/intellectual disabilities, veterans and others. The Committee members and the community participated by completing a short survey after the presentation.

E. Thorsen – Can you tell us about the project you mentioned at the historic Stuart High School campus building?

T. Hill – It is located on the east end of the main downtown corridor and is one of the few remaining buildings from the 1920s. The site will be a backbone for the arts. The vision is to increase access to the arts by hosting art camps, art studios, rented space for artists, café space, an auditorium, and workshops.

R. Sexner-Cole – I am part of a jazz band and would love to participate and be part of the MartinArts Sunset Concerts.

**Agenda Item: 25-0053, Hobe Sound NAC – CRA Architectural Design Standards**

Dana Little, Urban Design Director and Jessica Seymour, Principal Program Coordinator from the Treasure Coast Regional Planning Council presented the proposed CRA Architectural Design Standards for all six Martin County CRA areas. This effort has been undertaken to update and codify the design standards for clarity and predictability of use by architects, builders, property owners and staff, and to continue to implement the vision of well-designed communities that celebrate their distinctive identities and contribute to the overall sustainability of Martin County.

B. Krebs – Are these styles a guide for developers or can they use other styles not on the list? How will the styles be regulated to the developers? What if they don't want to use what is listed?

D. Little – The styles presented will be the standard styles for all the CRA areas. We recommend the developers to first talk to their CRA Program Managers and if they don't see one that fits for them, they could do an alternative compliance application.

S. Kores – If an applicant decides to do an alternative compliance application, it will need to be approved by a public body like the CRA Board, Local Planning Agency, or Board of Zoning Adjustment.

E. Thorsen – I don't see how Art Deco and Classical would fit for Hobe Sound. Are these styles both for residential and commercial areas?

D. Little – Yes, it would apply to both residential and commercial.

M. Miller – The Ranch style should be removed as it is a vague style and wouldn't fit in the Hobe Sound CRA.

R. Sexner-Cole – I would keep the Mission style.

J. Haggor – Why are we limiting it to these styles?

D. Little – This update will make it more flexible for developers.


