GoLine is Indian River County's fixed-route public transportation system and is operated by Senior Resource Association, Inc. (SRA), under contract with the County. The following performance measures are provided in accordance with Florida Statutes Sections 341.071(2) and 341.071(3), which require all public transit providers receiving State Public Transportation Block Grant funds to establish and publish productivity and performance measures annually. Indian River County annually receives these funds to supplement transit operating assistance funds received from the Federal Transit Administration. Funds are used to operate the County's public transportation program. Service includes fourteen fixed routes and a demand response program. The following performance measures are for the 2021/22 and 2022/23 fiscal years.
