




OVERALL PUD ~3,900 acres






ZONING ATLAS

THE RANCH PUD - PHASE 1 (~1,842 ACRES)






THE RANCH PUD

- Approved in April 2024
- 1st PUD Amendment with Revised Master Site Plan and Revised Phasing Plan approved in October 2024
- Bonafide agriculture; 175 single-family lots; two (2) 18-hole golf courses; short course; range house and training center; golf practice facilities; clubhouse; golf cottages; recreational and accessory uses; residential multi-slip docking facility; maintenance facilities; and supporting infrastructure.

THE RANCH PUD - PHASE 1 FINAL SITE PLAN

- ~1,842 acres
- Two (2) 18-hole golf courses, short course, clubhouse, cart barns, operations/maintenance facility, range building, training facility, seven golf cottages, and associated infrastructure
- ~500 acres of bonafide agriculture
- 196.4 acres of wetland preserve
- 121.62 acres of wetland buffers/upland preserve
- One internal roadway connection to SW Kanner Highway and one internal roadway connection to SW Bridge Road with turn lanes
- Equestrian trail in the SW Bridge Road right-of-way
