Rio Marine Village, Phase II (West)

Major Final Site Plan Application

September 29, 2025

On behalf of Rio South Dixie, LLC, please accept this as our formal request for approval of the Rio Marine Village (Phase II-West) Non-PUD, Major Final Site Plan Application. Phase II (West) is comprised of 6.11 acres; 0.084 acres are proposed to be dedicated to Martin County, leaving a net 6.029 acres of development area. The final site plan for The Rio Marine Village Phase II (West) proposes a mix of building types and uses. The Western Final Site Plan proposes waterfront commercial space, a mixed-use building, and two restaurants. Two existing single-family residences are included in the site plan and are intended to remain as such as part of Phase II.

The proposed mixed-use development project within the RIO Community Redevelopment Area of Martin County is supported by the development requirements of the CRA, as well as the intent of the CRA. Throughout the planning process of the proposed development plan, the surrounding community has voiced their support for the project. Restoring the rundown marina, improving the infrastructure, and providing the community with public access to the waterfront are only a few of this project's great benefits. The Martin County Commission has approved a Master Site Plan application through Resolution 22-2.1. The proposed Major Final Site Plan application is consistent with the approved master plan.

Rio Marine Village was designed to incorporate a variety of opportunities for traditional neighborhood design and mixed residential and commercial uses in the Rio Community Redevelopment Area (CRA). The Rio Marine Village project has gone to great lengths to ensure that the development in the Rio CRA complies with the Martin County Comprehensive Growth Management Plan. This project was designed with the form-based code design principles that foster predictable built results and a high-quality public realm by using a physical form, rather than total separation of uses, as the primary organizing principle of the development.

Site Plan

The Proposed final site plan for RIO Marine Village Phase II (West) includes residential and non-residential uses as part of a thoughtful and high-quality mixed-use development within the heart of the RIO CRA. Phase II (West) is intended to be the second portion of the development to begin vertical construction, but it is the intent of the developer for the entire project (Phase I and II) to be constructed at one time.

A total of 190 residential units are proposed to be built within Phase I (East) of Rio Marine Village. Within Phase II (West) there are two existing single-family residences that are proposed to remain as part of the development project. Also included is approximately 9,681 SF of marine service space, a 12,411 SF mixed-use building with a 3,200 SF covered patio, and 12,953 SF of restaurant space with 2,520 SF of covered patio.

Phase II (West) primarily contains the non-residential portions of the overall master plan for Rio Marine Village. The development has been designed to be consistent with the goals and objectives of the comprehensive plan and the Community Redevelopment Area Zoning codes. The Florida Coastal architectural style of the buildings compliments the history of the Rio CRA and enhances the community for the surrounding residents. Consistent with the Master Plan approval, the site plan includes the extensive network of public access sidewalks and walking paths along the water frontage. Community green spaces and gathering areas promote the appreciation of the St. Lucie River and the outdoors as a whole.

There are two subdistricts of the CRA Regulating Plan located within the limits of the Rio Marine Village project, Core and Waterfront.

Waterfront Subdistrict

Marinas and working waterfronts define this subdistrict. In the Rio CRA, the Waterfront subdistrict also promotes a mixed-use waterfront environment with restaurants, entertainment, resorts, and residential uses. Several elements designed to activate the waterfront while maintaining the goal of keeping the waterfront available for water-dependent and water-related uses have been included in the project. These elements are achieved in this project through the revitalization of two existing boat basins. These boat basins will heavily contribute to the activation of the waterfront by providing public access to the proposed waterfront restaurants, public boardwalk, and open-air green space. The proposed marine building is perpendicular to NE Dixie Hwy, facing a proposed project entrance. The location of the access point and the elevation of NE Dixie Hwy creates an open and expansive water view that features the naturally beautiful vistas of the St Lucie River. The marine buildings will provide space for marine uses that require a working waterfront environment but will be designed to encourage pedestrian window shopping. The mixed retail/industrial environment will cater to marine uses such as custom fabrication, boat repair/upgrades, electronics sales, custom rod manufacturers, and more.

Core Subdistrict

The project is designed in line with the intent to be a pedestrian-oriented center for surrounding neighborhoods and the entire CRA. This is accomplished by carefully curating the mix of uses. The marina and commercial waterfront will make RIO Marine Village a destination for boaters, neighborhood pedestrians, and locals that want to experience waterfront activities. The site will include a waterfront park, walking paths, waterfront restaurants, and associated retail that will allow the community to enjoy the waterfront. The proposed residential units are designed to provide housing for young families and current Martin County residents looking to downsize to a simpler lifestyle, and all three-story buildings will include elevator access.

The mixed-use and marine industrial uses will provide both daytime activities to help support the restaurants and provide the community with an environment where they can work and play along the river.

Primary and Secondary Streets and Alleys

NE Dixie Highway, a Primary Street designated by the CRA Street Regulating Plan, abuts the northern boundary of the Rio Marine Village. Three access points are proposed from NE Dixie Hwy along the north perimeter. The existing roundabout at the intersection of NE Dixie Hwy and NE Martin Ave is proposed to be relocated to the east about 300 feet. The intersection of Dixie and Martin Ave would then be reconfigured to be a standard unsignalized intersection. The westernmost access point is also proposed as a round-about, providing a bookend to the development, and signifying another arrival point. NE Martin Avenue, another Primary Street designated by the CRA Street Regulating Plan, provides access through the center of the project on land that is not included within the bounds of the project.

The RIO Marine Village redevelopment project is positioned within an area of previously developed lands and existing/occupied properties. An established network of streets has influenced the organization of the development and the positioning of buildings. By utilizing the existing street network of NE Stuart St., NE Bernard St., NE St. Lucie ter., and NE Martin Ave, a block network of development have been created. This further promotes the development guidelines within the Martin County RIO Community Redevelopment Area Land Development Regulations. Additionally, conforming to the existing infrastructure allows for more connectivity and sustainable design.

Required Commercial Frontage

While designing this project, the design team followed the intent of Primary Streets within the CRA, which is to support businesses, civic uses and reinforce local character. It's understood that these streets are designated as Required Commercial Frontage and shall be non-residential and open to the public at the ground level. The frontages of the buildings along Dixie shall be shopfronts and arcades.

Marine Service Areas

This project complies with the intended use of the Marine Service Areas that are located within the bounds of this project. The marine building adjacent to the west boat basin is proposed to be used by marine industrial users while providing an inviting atmosphere for those users to market their product to the general community, boaters that will have access to the public docks, boat owners that rent docks at the marina, and those visiting the attractions at RIO Marine Village. A serviced marina without fuel sales is proposed to provide various boat storage options, including two boat basins designed to provide protected wet storage for 40-50 boats up to 50' in length, and one finger pier with wet storage designed for boats up to 80'. The marina will include a ship store with yacht provisioning, retail sales, and other light services. Day dock public access will allow the community to utilize our public waterfront park and visit our marine industrial users, restaurants, and retail. The final site plan is designed to satisfy the required twenty-five-foot (25') shoreline protection zone.

Section 12.1.03. Permitted Uses

This project complies with this section of code. All proposed building uses are allowed in the subdistrict it is proposed within. In the Core subdistrict areas of the Rio Marine Village final site plan, Live Work units, apartments, and restaurants are proposed. Apartments, townhomes, restaurants, Marine Industrial, Mixed Use Office, and limited impact retail and services are proposed within the Waterfront subdistrict areas of the Rio Marine Village.

Section 12.1.04. Development Standards

<u>Height-</u> All proposed building heights comply with height standards, and no building height exceeds the 40' and 4-story height limit. Ceiling heights for this project were measured from finished floor elevation to finished ceiling.

<u>Building Coverage-</u> The calculation utilized when determining building coverage is the horizontal area measured from the building footprint of the roofed area at the ground floor of the principal and accessory structures on the lot. The total Building Lot Coverage in Phase II (West) is 31,924.36 SF.

<u>Open Space-</u> This project will comply with the open space requirement of 20%. Total amount of open space required in the Rio Marine Village is 3.24 acres. The master plan provides 7.52 acres of open space, well exceeding the requirement.

<u>Shielding from Street-</u> This project was designed to ensure a pleasant visual experience for all the future residents and visitors by shielding any unsightly maintenance equipment, antennas, satellite dishes and other similar structures from the right of way.

Policy 18.5C.1 Shoreline Protection Zone

The Rio Marine Village satisfies the 25' landward from shoreline setback and is redeveloped in accordance with this policy. There was 50,692 SF of impervious ground coverage existing in the project site. An Existing Impervious Conditions Map and chart detailing the total impervious square footage in the project have been provided.

This project's total square footage of Shoreline Protection Zone is <u>78,908</u> SF. Proposed impervious surfaces do not exceed 40% of the SPZ area. Pervious walkways are provided within the Shoreline Protection Zone, as allowed by this policy, to provide public access to the water or connection between adjoining properties. Any development and redevelopment in the proposed project protect the shoreline mangroves, incorporate a living shoreline element and meet the minimum stormwater requirements for rate, quantity, quality, and timing of the discharge. We were diligent in ensuring that development and redevelopment do not contribute to shoreline erosion.

The Applicant proposes a pervious public boardwalk along more than 50% of the project's shoreline. This public space will front portions of the living shoreline and provide direct access to the beach for residents and visitors to enjoy.

Alternative Compliance

There are Alternative Compliance requests associated with this project, see attached PDF for details. The specific alternative compliance requests are detailed within a separate justification statement. All the requests are a direct result of the innovative design measures taken to create a development that fits within the unique property boundaries and the surrounding development. These alternative compliance requests are necessary to create a project that is consistent with the intent behind the design requirements listed within the RIO Community Redevelopment Area Land Development Regulations.
