Introduction of new board member, Christina Ouillette and new Code Compliance investigators Rick and Charles "Chuck."

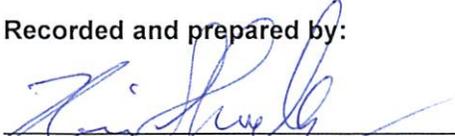
X. ADJOURNMENT:
