**AMENDMENT TO AGREEMENT BETWEEN
MARTIN COUNTY BOARD OF COUNTY COMMISSIONERS
AND SENIOR RESOURCE ASSOCIATION**

THIS AMENDMENT #2 made and entered into this 4 day of April in the year 2025, by and between **MARTIN COUNTY**, a political subdivision of Florida, (“County”), 2401 SE Monterey Road, Stuart, Florida 34996 and **SENIOR RESOURCE ASSOCIATION**, a Florida non-profit organization (“Contractor”), 694 14th Street, Vero Beach, Florida 32960.

WITNESSETH

WHEREAS, the **County** and **Contractor** entered into an Agreement for transit services to the Transportation Disadvantaged on July 1, 2024 (“Agreement”); and

WHEREAS, the State Florida Commission for the Transportation Disadvantaged (“State”) and Contractor entered into a Trip & Equipment Grant Agreement on July 1, 2024, and

WHEREAS, the County shall provide a 10% match for the monthly allocation disbursement schedule of the Trip and Equipment Grant and a \$58,282 overmatch, and

WHEREAS, on December 10, 2024, the County approved Amendment #1 of the Agreement that included additional overmatch in the amount of \$150,000 and

WHEREAS, the **County** and **Contractor** desire to amend the Agreement again consistent with the Trip & Equipment Grant Agreement between the **State** and **Contractor** due to additional trips.

NOW THEREFORE, in consideration of the promises, covenants, and mutual benefits which all accrue to the parties hereto in carrying out the terms of this Amendment, it is mutually covenanted and agreed that the Agreement will be amended as follows:

1. Paragraph 1 of Section C, PAYMENT, of the Agreement is hereby revised to include a second additional overmatch in the amount of \$161,000.
2. All remaining pricing and terms and conditions of the Agreement not specifically amended herein shall remain in full force and effect.

IN WITNESS WHEREOF, the parties hereto have executed this Amendment to the Agreement as of the date first set forth above.
