OLD BUSINESS

Agenda Item: 26-0263, HOBE SOUND NAC – STAFF UPDATES

Jana Cox provided updates on the Unpaved Roads project, Hobe Sound murals, Dixie Stormwater & Streetscape project, and Sun Trail.

NAC members briefly discussed the train landscaping project.

COMMENTS

1. Public-

G. Miller – I am glad that the lights were completed, but what about the areas that are still not lit, such as the park area? There are still dark sections, and the trees block the lights on Lantana. There are also some poles with no lights installed.

M. Gavin- Are we going to be installing more of the wraps?

J. Cox- I will check into adding more wrapped electrical boxes to Hobe Sound.

E. Thorsen- Any updates on the Lares presenter returning to the NAC?

J. Cox- Not currently.

G. Miller- I am concerned about the project happening near the school.

M. Gavin- If you go online, you can see all the dates and information about the project, including milestone updates.

J. Cox- Growth Management is the department providing updates for this project.

E. Thorsen- Can we have someone from Growth Management attend one of the NAC meetings, or at least provide information on what is expected for 2026?

J. Cox- There are several factors involved in project development, including revisions to staff reports, the development review process, and the applicant's own actions.

M. Miller- For the townhomes on Dixie, the applicant is expected to submit a building permit next week.

W. Scott- I am deeply concerned about the traffic on Neptune and near Pine School. I have grandkids and kids who are at risk because of the speeding, and this needs to be addressed now—before a child gets hurt or killed. Police need to be present, issuing tickets, and stopping the speeders.

J. Cox- We need a speed study completed, and once that is done, we can move forward with resolving these issues. Let me do some research and follow-up with you.

G. McClain- This is a serious issue. I can't even get out of my driveway.

T. Green- We hear your concerns. This is not a new issue for Martin County; the entire county is experiencing problems with traffic, speeding, and motorists not stopping for school buses. We can certainly place an officer in the area, but tickets alone do not stop speeding, and an officer cannot be present all the time.

W. Scott- We need support. A child could be killed.

T. Green- We cannot ticket our way out of the problem. That's not an effective long-term solution.

Commissioner Capps- Martin County's growth rate is low—around 2%. Tomorrow, I'll be discussing these issues and development signage at the Chamber's Breakfast. Much of the


speeding traffic likely comes from St. Lucie and Palm Beach counties. While Martin County has managed growth well, property owners have rights, and we can't prevent development altogether. Minor site developments don't even go before the board.

M. Banas- They meet the code and are under 50 units.

Further discussion ensued among the NAC members, the presenter, the Sheriff's Department, and county staff regarding upcoming developments, traffic-control measures, traffic patterns, speeding, speed bumps, hazardous streets, children walking to or waiting at bus stops, police presence, the possibility of conducting a traffic study, and additional lighting.



