## AGENDA ITEM: 24-1276, Old Palm City – CRA Architectural Design Standards

Dana Little, Urban Design Director from the Treasure Coast Regional Planning Council presented the proposed CRA Architectural Design Standards for all six Martin County CRA areas. This effort has been undertaken to update and codify the design standards for clarity and predictability of use by architects, builders, property owners and staff, and to continue to implement the vision of well-designed communities that celebrate their distinctive identities and contribute to the overall sustainability of Martin County.

- B. Bols Will this interfere with the ADA requirements?
- D. Little There are no conflicts.
- R. Sentell Contemporary, Art Deco, and Classical Tradition should not be added for Old Palm City.
- C. Pinkston What sprung the design standards?

S. Kores – On our last code revision we did not get to this and it needed to get updated. This update will help navigate developers.

- C. Pinkston I agree with Rex Sentell to eliminate the three and no Anglo-Caribbean.
- R. Corbett Could certain areas be restricted to specific styles?
- J. Landrum I like the Mission style.
- R. Sentell I really don't want all the CRA areas to be the same.

#### AGENDA ITEM: 24-1277, Old Palm City – Alternative Compliance at 906 SW All American Blvd.

Jordan Pastorius, CRA Assistant Manager, presented a project requesting a recommendation from the committee for alternative compliance for the installation of an 846 square foot metal garage. The proposed structure does not comply with the Land Development Regulations as it does not match the architectural style or building form of the principal building. The applicant (Russell Finley) voiced his request for approval of the alternate compliance.

- C. Pinkston Is there room for it to be set back?
- J. Pastorius Its about 51 feet from the water.
- O. Torres What are the neighbors' thoughts on this metal garage?
- C. Pachowicz Can it be more compatible to the code?

R. Finley – I have gone around to my neighbors with a letter asking if it is okay and they signed off on it. (the letter has been saved for records) I have no landscape for it now, but I will once its completed. During this time, I have some coconut trees around for landscape.

C. Pachowicz – I'm glad you were able to talk to your neighbors about this.

C. Pinkston – If we decide to do the Enhanced Neighborhood Streets project I don't to the neighborhood to think we are taking away their land. We need to do some kind outreach for communications for them. J, Landrum – At the end of 31<sup>st</sup> Street please remember there are mangrove trees.

Port Salerno CRA

5703 SE 47th Avenue - 1 lot, CRA Neighborhood FLU and Detached Subdistrict SE Geraldine Street/SE Railway Avenue - 8 lots, CRA Neighborhood FLU and Detached Subdistrict

- Golden Gate CRA Hawthorne Street - 10 lots between SE Hawthorne and SE Iris Streets, CRA Center FLU and General Subdistrict
- Old Palm City CRA
  3500 SE Old Palm City School Avenue 1 lot at 3500 SW Palm City School Avenue, CRA
  Center FLU, Corridor Subdistrict

B. Bols – Are you kidding? After buying the Old Palm City lot now we are going to develop it with more housing. I've had a problem with the County purchasing the lot from the beginning.

S. Kores – There will be an RFP (request for proposal) that will go out for bid based on with the community would like to see.

E. Ciampi – What's being done is a state requirement. Once the RFP goes out to bid there will be restrictions on what could be built.
