THIS MATTER having come before the Magistrate on October 18, 2023, and having heard the testimony and other evidence of the parties, and having been fully apprised of the circumstances, and based upon a preponderance of the evidence, does find as follows:

1. This Fine Reduction Stipulation and Agreed Recommended Order involves a parcel located at 5532 SE NASSAU TERR, STUART, FL 34997, Martin County, Florida and further described as:

Lot 71, ROCKY POINT ESTATES, second map, according to the Plat thereof filed March 18, 1957, and recorded in Plat Book 3, page 63, public records of Martin County, Florida.

- 2. On January 20, 2021, an Order Finding Violation was issued by the Code Enforcement Magistrate to SHAIKH SHAHID HALEEM, for the following violation(s):
 - Section 67.201.B Nuisance Declared: Trash, Etc General Ordinances, Martin County Code
 - Section 21.115 Roof and Drainage- General Ordinances, Martin County Code

Compliance was required by February 28, 2021. On December 2, 2021, an Affidavit of Transition and Accrued Fine and Costs was issued reflecting an outstanding fine of \$ 26,400.00 plus costs in the amount of \$ 575.00.

3. Staff has determined that a lien reduction is warranted. The respondent was responsible for the violation; the County brought the property into compliance under Unsafe case ENF2020090500, and the Personal Representative have offered to pay \$2,697.50 to resolve the outstanding fines which have accrued.
