## **PRESENTATION**

**Agenda Item: 26-0078, CRA CAPITAL PROJECTS REVIEW – September 22, 2025**

Susan Kores provided a monthly review of active capital projects and an introduction of new projects.

**Agenda Item: 26-0097 CRA Project Review- Hobe Sound Unpaved Roads, Jensen Beach Maple Ave. drainage.**

Jane Cox provided a review of the Hobe Sound CRA Unpaved Roads project and the Jensen Beach drainage project.

## **COMMENTS**

J. Rolle Taylor- Will all the CRAs be coordinating with Public Works on unpaved road projects?

S. Kores- Our first approach is to coordinate with Public Works on unpaved road projects. For example, in Golden Gate, we partnered with them since they were already working in that area.

J. Rolle Taylor- It is ideal to coordinate with Public Works, particularly considering the unpaved roads projects underway across the CRAs.

## **OLD BUSINESS**

**Agenda Item: 26-0098** Golden Gate Neighborhood Improvement project update

Yuen Dang, Principal at DDEC, presented updated designs for priority street sections within the Golden Gate Neighborhood, and educated the Board members on traffic calming challenges and solutions as well as discussed the pros and cons of the street sections presented.

## **COMMENTS**

S. Tsafarides- Do the designs consider cul-de-sacs?

Y. Dang- Limited right-of-way makes them impractical on streets like Fairmont.

C. Smith- Have you seen the mini-roundabout on High Meadows in Palm City — is it too small?

Y. Dang- Roundabouts are designed with an outer circle and a textured inner circle to allow larger vehicles to make tighter turns. The design of the mini-roundabout on High Meadows makes sense — it supports smooth traffic flow by slowing vehicles without restricting movement.

C. Smith- Is there a plan to implement landscaping now or in the future, considering the tire marks in the center?

Y. Dang- I will visit the site. Since our right-of-way widths range from 50 to 100 feet, each roundabout needs to be designed accordingly. We have identified some potential sites and will present them at a future meeting.

J. Rolle Taylor- Can the road at Hemlock be connected from Indian to Kensington?

Y. Dang- We lack right-of-way in that area; focus remains on locations with available right-of-way.

R. Krebs- Do the designs account for underground utilities to keep them clear of planting areas?

Y. Dang- Our final designs fully account for these issues.

R. Krebs- Are 10-foot lanes typical?

Y. Dang- Within the CRA, smaller streets have 10-foot lanes, while Jefferson Street uses 11-foot lanes for heavier traffic.

R. Krebs- Placing the multi-use trail in the middle seems beneficial for safety and connectivity.

Y. Dang- The trail placement offers parking and landscaping benefits but raises safety concerns requiring possible crosswalks.

S. Kores- Considering parking adjacent to the pathway slows traffic, do members find this design suitable for the CRAs?

R. Sentell- This concept raises safety concerns if applied to Indian Street, due to high traffic and parked cars.

S. Kores- Would you prefer a design without parking?

R. Sentell- Parking is tight on Indian Street; it may be better kept on the neighborhood side. The concept suits less congested areas.

Y. Dang- Designs can be flipped or adjusted to meet neighborhood needs.

Further discussion took place between the CRA members and the presenter concerning the overall design and the multi-use trail.
