Agenda Item: 25-1287, JENSEN BEACH NAC - RESILIENT MARTIN PRESENTATION ON MARTIN COUNTY'S VULNERABILITY ASSESSMENT

Amy Eason, Environmental Resources Engineer with Martin County Public Works, presented Resilient Martin and the exposure risk of Martin County through a Vulnerability Assessment, and its effects on the local communities throughout Martin County. This assessment includes sea level rise, storm surge, rainfall, and combination flooding as well as exposure, vulnerability, adaptive capacity, and sensitivity thus allowing for recommendations, community engagement, and planning.

J. Cox- We can address issues within the Martin County right-of-way.

A. Kagdis- Expressed her gratitude to everyone for attending the meeting and for voicing their concerns about the community.






