COMMENTS

1. PUBLIC

- J. Hatton – I will be here until the house across the street is gone: 3117 SE Golden Gate Ave
- M. Moore – Someone bought it
- S. Tsaftarides – Be patient it will be taken care of
- D. Stasevich – I am interested in getting involved with Golden Gate
- W. Scherer – We are 2 ½ weeks away from Christmas and we were promised that the streetlights on Norman would be fixed. This is two blocks from Dixie on Norman and the lights were not put back in. Also, since that new lake was built, several homeowners had to have septic tanks pumped out. Is this project creating more water?
- J. Mills – It is that time of year when the King Tide is affecting the water tables, and coupled with the heavy rain we've been getting, there are a lot of issues throughout the County for properties

near the water. There has not been a new lake built, I believe you are referring to one of the existing STAs, and they are the antithesis of creating/adding water – the high water levels do not have anything to do with the water treatment area.

- J. Vitale – Can we make the county aware of the issue?
- J. Mills – Public Works is educating the public about King Tides through the Martin County website and social media. They are asking citizens to submit pictures and issues just like this. Golden Gate will be on sewer soon, thus alleviating any future issues of this nature. At our next meeting in February, Phil Keathley of Public Utilities will be presenting an overview/update of the sewer project.
- Deputy Sprott – I am back in the community for now, and not working between here and the schools. There has been some crime in Golden Gate (minor burglaries), so please always keep your cars locked and be aware of keeping purses and items of importance out in the open.

2. MEMBERS

- R. Hartman – Can we see if a large portion of the park can be covered? We have lots of kids in Golden Gate and no protection from the sun.
- S. Tsafarides – We are going to have the Camino Trail with lots of covered areas.
- J. Mills – The trail is a linear park which features covered areas.
- C. Ramsey – For the Dixie Highway project, will there be any turn lanes placed on either Ellendale or Fairmont for access to the park?
- J. Mills – The project includes 5 turn lanes, and so far, Delmar is the only location that has been identified as a priority. I would have to assume easy access to the park is also a priority, as this is the main center of Golden Gate.
- J. Vitale – I see that we have a CIP sheet included in our package. Can we see a wrap up of how the 2019 funds were spent?
- J. Mills – This topic will be covered when I present the CIP for fiscal year 2021 in a few minutes. Susan Kores will be here in February for our next meeting to present the final update and recommend a motion to approve CIP funds.
- M. Moore – Crime is down in Golden Gate and I would like to thank the Sheriff's Office for that.
- R. Hartman – I feel that the lighting plan is a serious issue. Does the county have a lighting plan that shows where lights have been installed?
- J. Mills – There is a plan in place for the LED light swap, but this is different than an actual Countywide lighting plan. We have a department in Public Works that is tasked with lighting in the County and I will see if they have lighting plan in place.
- S. Tsafarides – We had a lighting survey done by the Sheriff's office. The lighting will go in after the sewer is done so that we do not tear up the streets twice.






