IV. Agenda Items

A. County Capital Improvement Programs

Senior Project Engineer Chris Goetzfried presented the update. The presentation included: Neighborhood Restoration Design projects, Resurfacing and Roadways, Sidewalk projects, Bridge projects, CRA Construction projects, Ecosystem projects, and Coastal projects.

Environmental Resource Specialist Katie Bowes provided updates on stormwater treatment areas and channel enhancements.

Capital Engineer Manager Lukas Lambert provided traffic safety updates.

B. City Utilities and Engineering Projects

Stuart Utilities & Engineering Director Tim Voelker presented the City's update to the Boards. The presentation included: Shepard Park Boat Ramp, Stormwater projects, Sailfish Ballfield Forcemain, and the City's alternative water supply.

C. County and City Large-Scale Development Projects

Principal Planner Samantha Lovelady provided a presentation on large scale projects that are currently under review. Comprehensive Planning Administrator Clyde Dulin assisted with questions.

City Development Director Kevin Freeman presented the City's development review and Comprehensive Plan Amendments to the Boards.

D. Village of Indiantown Projects Update

Community and Economic Development Director Althea Jefferson provided capital improvements updates for the Village of Indiantown.

E. School District Update

Superintendent Dr. John D. Millay provided the update for the school district. Director Jennifer Deshazo provided safety measure updates. Director of Facilities and Planning Mark Sechrist presented facilities and construction updates. Capital Projects Planner Kimberly Everman presented planning and enrollment updates.

Chief Academic Officer Dr. Tracey Miller gave a brief update on the District's current state of affairs. Chair Marsha Powers advised the Boards there will be an update to the Indiantown bus routes for emergency situations. She also explained that masks and vaccines will be optional for the upcoming school year.

Mayor Eula Clarke inquired about the implementation of recently passed federal legislation on Juneteenth declarations into the school's curriculum. Mayor Janet Hernandez inquired about a Cultural Department and embracing culture in the schools. Chair Marsha Powers advised that the District has educational programs and course curriculum in place.

Vice Chair Anthony Anderson thanked the County Commissioners and staff on their responsiveness. Debbie Trythall commended the Boards for their cooperation during this school year.

Additional Comments

Commissioner Meier suggested acquiring conservation lands in the county for ecological benefits and future proofing. Michael Diterlizzi suggested the use of a conservation map throughout the county to help with future planning.
