### Democrats: Trump ads in Fla. a sign of nervousness

Amid the millions of dollars former President Don-ald Trump is spending on television advertising to blunt Kamala Harris momentum, one small ad buy is drawing keen attention.

The Trump campaign bought \$48,000 worth of advertising in Florida in the West Palm Beach media market where the former president lives, according to ad-tracking firms AdImpact and Medium Buying. The 15-second cable ads will begin airing Tuesday.

Democrats jumped on the ad buy to argue that Trump's team is nervous about Florida, where a pair of new polls show a tighter race than expected.

Florida Democratic Party Executive Director Phillip Jerez shared details about the Trump ad buy on X and wrote, "Donald Trump is scared of losing Florida."

A USA TODAY/Suffolk University/WSVN-TV survey released this month found Trump leading Harris by 5 percentage points in Florida, while a Florida Atlantic University survey had Trump up by 3 points.

Trump tripled his margin of victory in Florida in 2020, winning by 3.3 percentage points, and Gov. Ron DeSantis won reelection by an overwhelming 19 points in 2022, leading many to conclude that the nation's largest swing state is no longer competitive.

But Harris has energized Democrats, including in Florida, where the party is trying to rally its base to

take on Trump and Republicans down the ballot, including U.S. Sen. Rick Scott. Democrats are pointing to the Trump campaign ads as proof the state is in

"We told you that Trump would start to put money on TV in Florida," Florida Democratic Party Chair Nikki

Fried wrote on X.

The ads running in West Palm Beach could just be for an audience of one, though. Trump, whose primary residence is his Mar-a-Lago estate in Palm Beach, is known to be a voracious consumer of televi-

sion news. "Florida is deep red, Trump country but we will never take any state for granted," Trump spokesman Brian Hughes said in a statement. "We have robust campaign organizations across the nation and make investments throughout."

An analysis by the Weslyan Media Project found that 44,000 ads backing Trump have aired nationally since mid-July, compared to 32,700 promoting President Joe Biden, who dropped out of the race on July 21, or Harris

or Harris.

"However, spending is greater on the Democratic side, with about \$63 million in spending versus about \$49 million spent on ads promoting Trump," according to the group.

The ad spending has been concentrated in the key

Arizona, Georgia and Nevada, Combined, Republicans Arizona, Georgia and Nevada. Combined, Republicans and Democrats spent more than \$4 million on television ads for the presidential race in six media markets since mid-July Philadelphia, Phoenix, Atlanta, Harrisburg, Pittsburgh and Detroit.

The media market with the most presidential ad spending is Philadelphia at nearly \$12 million.

#### Trump not attending Sept. event for Jan. 6 defendants

Fundraiser scheduled to be at his New Jersey golf club

Donald Trump's campaign says he won't be attending a fundraiser for families of people who were charged in the Jan. 6, 2021, Capitol riots after the former president was listed as an invited speaker for the

mer president was listed as an invited speaker for the event at his New Jersey golf club.

More than 1,400 people have been charged in the attack on the Capitol, and Trump has been federally indicted on election interference charges that allege he played a part in inciting the violent mob.

The "J6 Awards Gala" by nonprofit Stand in the Gap is scheduled for Sept. 5 at the Trump National Golf Club—Bedminster. According to the listing online, the event will raise money and pay tribute to "all J6 defendants who have shown incredible courae" and sacrifices"

Trump is listed as an invited encel-confirmed speakers Rudy Giuliani an mondi. The Trump campaign told USA To not be attending.

While Democrats hammer Trump for the eve that day, Trump has suggested that those convicts the riots should be released. He has also played record ings from the J6 Prison Choir at his rallies. The Stand in the Gap fundraiser also will honor the choir's song "Justice for All."

Several people online have reacted to the event in disbelief, including former Mike Pence adviser Olivia

'Troye.

"Celebrating the people who endangered the life of (Trump's) own Vice President & glorifying violence is a dangerous assault on our democracy & a disgraceful rewriting of history," Troye, who endorsed Vice President Kamala Harris, wrote on X. "We must all stand

together against him." Sen. Lindsey Graham, R-S.C., avoided weighing in on whether Trump should attend the event but condemned the rioters.

demned the rioters.
"I have no sympathy for those who broke into the Capitol, destroyed the place and hurt police officers," Graham said on CNN's "State of the Union" Sunday. When pressed on whether Trump should allow the event to happen, Graham responded, "I'll leave it up to him as to what causes to support."

On Jan. 6., 2021, a group of demonstrators breached the U.S. Capitol while Congress was in the process of affirming the 2020 election results, in which President

affirming the 2020 election results, in which President Joe Biden beat Trump. Approximately 140 police officers were assaulted at the Capitol that day, according to the Department of Justice. Five people at the riot died of varying causes and at least four police officers who responded to the Capitol riots died by suicide in the months after the incident.

As of May 2024, 1.424 defendants have been

As of May 2024, 1,424 detendants have been charged as a result of investigations into the riots, according to a Justice Department release.

The insurrection led to Trump's second impeachment. Trump has been indicted in a federal criminal case on charges that accuse him of trying to overturn the election, efforts that in part led to the Jan. 6 in-
