**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF  
MARTIN COUNTY, FLORIDA, RELATING TO THEDESIGNATION OF NW  
JENSEN BEACH BOULEVARD, NE JENSEN BEACH BOULEVARD, NE  
PINEAPPLE AVENUE, AND NE CAUSEWAY BOULEVARD AS COUNTY  
ROAD 732**

**WHEREAS**, roadway corridors may have multiple names simultaneously, as assigned by each agency with jurisdictional authority, with "US" referring to roadway corridors under FEDERAL jurisdiction, "SR" referring to roadway corridors under STATE jurisdiction, and "CR" referring to roadway corridors under COUNTY jurisdiction. Roadways without these acronyms are typically LOCAL roadways;

**WHEREAS**, Martin County and the Florida Department of Transportation, hereinafter, FDOT, executed a Road Jurisdiction Transfer Agreement, hereinafter, Agreement, on November 5, 2025;

**WHEREAS**, in accordance with the Agreement, the FDOT transferred its jurisdiction over SR-732 (NW and NE Jensen Beach Boulevard) between SR-5 (US-1 / NW Federal Highway) and CR-723 (NE Savannah Road) to Martin County;

**WHEREAS**, in accordance with the Agreement, the FDOT transferred and its jurisdiction over SR-732 (NE Causeway Boulevard) between CR-707 (NE Indian River Drive) and SR-A1A (NE Ocean Boulevard) to Martin County;

**WHEREAS**, pursuant to Section 336.05(1), Florida Statutes, the Board of County Commissioners are authorized to name and rename streets and roads, except state roads designated by number by the department, lying outside the boundaries of any incorporated municipality; and

**WHEREAS**, the Board desires to designate a continuous County route in Jensen Beach between SR-5 (US-1 / NW Federal Highway) and to Martin County.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY  
COMMISSIONERS OF MARTIN COUNTY, FLORIDA, THAT:**

The route along NW and NE Jensen Beach Boulevard between SR-5 (US-1 / NW Federal Highway) and NE Pineapple Avenue, along Pineapple Avenue between NE Jensen Beach Boulevard and CR-707 (NE Indian river Drive), and along NE Causeway Boulevard between CR-707 (NE Indian river Drive) and SR-A1A (NE Ocean Boulevard), as depicted on Attached Exhibit A, is hereby designated as County Road 732 (CR-732).
