A RESOLUTION TO RELEASE THE PRESERVE AREA MANAGEMENT PLAN FOR THE GRACE PLACE INC. PROPERTY

WHEREAS, this Board has made the following determinations of fact:

- 1. In 2005, Martin County issued Resolution No. DRC-05-2.1 approving the final site plan for The Grace Place that was recorded in Official Records Book 01998, Page 1992 through 1993, Public Records, Martin County, Florida. The resolution included a Preserve Area Management Plan (PAMP) attached as Exhibit C and recorded in Official Records Book 01998, Page 1996 through 2011, Public Records, Martin County, Florida.
- 2. In 2006, the South Florida Water Management District (Permit 43-01269-P, Application 061106-28) officially reclassified the 0.64-acre wetland as an "other surface water" (OSW) in accordance with Chapter 40E-4.021, Florida Administrative Code.
- 3. Drew Gatewood, on behalf of the property owner Grace Place Inc., has requested the release of the PAMP as the 0.64-acre wetland and associated wetland buffer has been reclassified by the State of Florida to a surface water and no longer requires protection under county code.
 - 4. This Board considered such request at a public meeting on September 23, 2025.
 - 5. At the public meeting, all interested parties were given an opportunity to be heard.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY, FLORIDA, THAT:
