There is a voluntary nighttime curfew from 11 p.m. to 7 a.m. for all aircraft (all prop aircraft, helicopters, and Stage I, II, and III jet aircraft). The only exceptions to this curfew are Air Ambulances, Rescue Aircraft, and United States Government Aircraft, for which there are no curfews. An operation is either a takeoff or a landing.

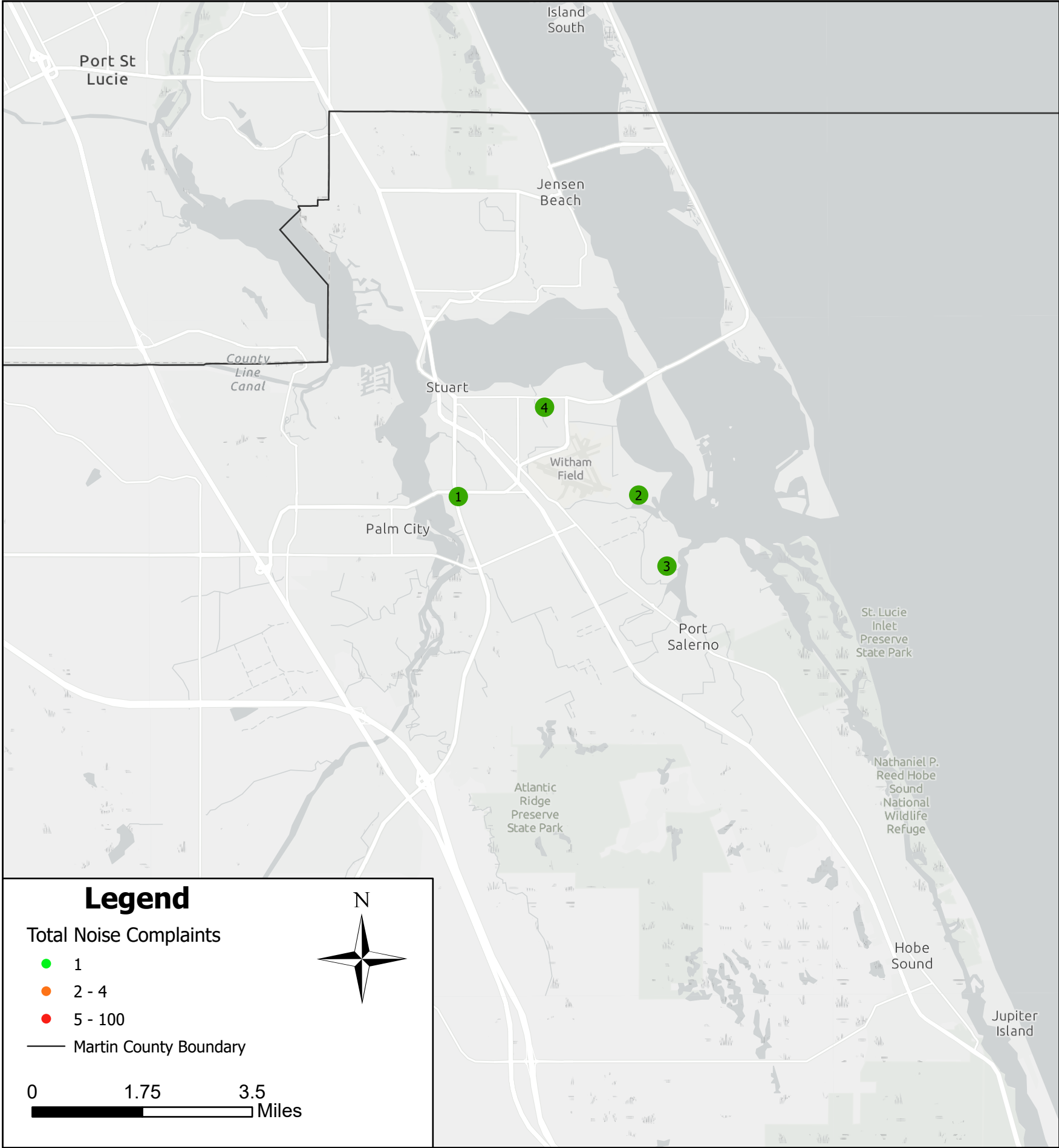
A total of **32 letters** were sent to aircraft operators that had an operation at Witham Field (SUA) during the Voluntary Curfew in June 2026.

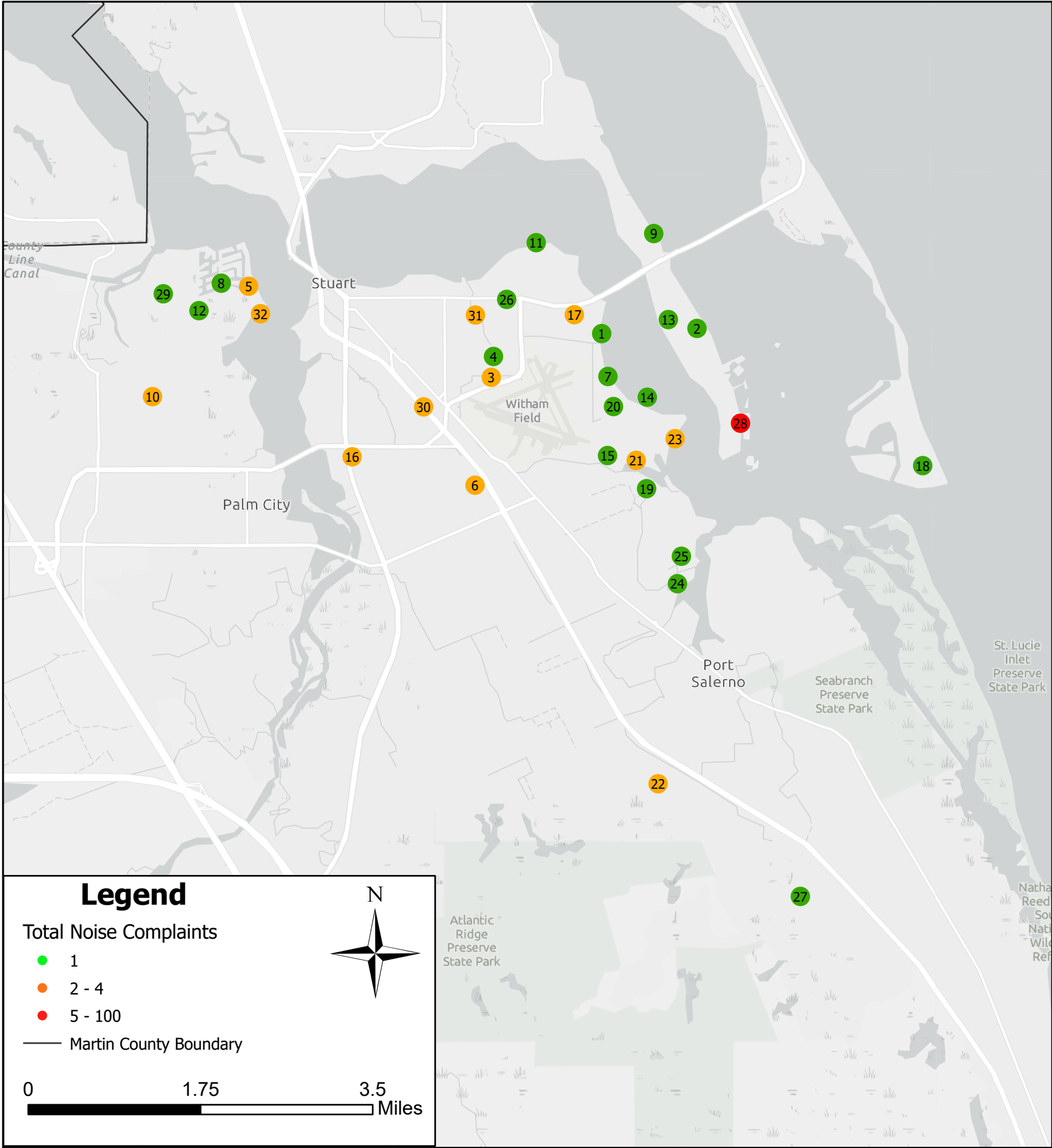
