95 Riverside PUD / Pulte I-95 (Camellia) Project Narrative October 26, 2023

Location & History:

The subject property is 12.40 Ac. and is a portion of an existing 24.96 Ac. Planned Unit Development known as "95 Riverside PUD" which is located on the north side of SW Kanner Hwy / SR 76, just east of the I-95 interchange.


The 95 Riverside PUD was originally approved in 1987 as a six-phase project with the last PUD amendment (8th amendment) approved in 2007. Only phases I, II, III A & B have been developed to date which include an existing sales center/ office, Chevron gas station, McDonalds, Cracker Barrel, and Marriot Hotel. The subject property was originally planned as phase IV, V, & VI with a range of commercial uses including a maximum of 158,900 sf of office, restaurant and bank uses. The property has sat vacant since the last development of the phase III B Marriot hotel which was constructed in 2008.

Subject Property – Proposal:

The applicant is proposing to construct a 98-unit single family townhouse community on the 12.40 Ac. subject property for a gross density of 7.90 DU/Ac.

Currently, there are two submitted applications associated with this project which are still under review:

- Small-scale Comprehensive Plan Amendment to change the future land use designation from General Commercial to COR.
- 9th amendment to the PUD and Master Plan along with a Phase IV Final Site Plan
