Russian airstrikes destroy power plant close to Kyiv

KYIV, Ukraine - Russian missiles and drones destroyed a large electricity plant near Kyiv and hit power facilities in several regions of Ukraine on Thursday, officials said, ramping up pressure on the embattled energy system as Kyiv runs low on air defenses.

The major attack more than two years since Russia's full-scale invasion completely destroyed the Trypilska coal-powered thermal power plant near the capital, a senior official at the company that runs the facility told Reuters.

Footage shared on social media showed a fire raging at the large Soviet-era facility and black smoke belching from it. Reuters was able to confirm the location of the video as the Trypilska station.

dymyr Zelenskyy said on Telegram, condemning the attacks as "terror."

The Russian defense ministry said it hit fuel and energy facilities in Ukraine in what it described as a massive retaliatory strike using drones and high-precision, long-range weapons from air and sea. The strikes were a response to Ukrainian drone attacks on Russia's oil, gas and energy facilities, it said.

Kyiv's appeals for urgent air defense supplies from the West have grown increasingly desperate since Russia renewed its long-range aerial assaults on the Ukrainian energy system last month. The attacks, which hammered thermal and hydroelectric power plants, have caused fears about the resilience of an energy system that was hobbled by a Russian air campaign in the war's first winter.

Ukraine's air force commander said air defenses

not eye-closing and long discussions," President Volo- took down 18 of the incoming missiles and 39 drones. The attack used 82 missiles and drones in total, the military said.

The destroyed power plant outside Kyiv, a major power supplier for the capital and Cherkasy and Zhytomyr regions, is the third and last facility owned by state-owned energy company Centrenergo.

"Everything is destroyed," Andriy Gota, head of the supervisory board of the company, said when asked about the situation at Centrenergo.

The Trypilska plant was the biggest energy facility near Kyiv and was built to have a capacity of 1,800 megawatt hours, more than the pre-war needs of Ukraine's biggest city.

The Ukrenergo grid operator said its substations and power generating facilities had been damaged in attacks on the regions of Odesa, Kharkiv, Zaporizhzhia, Lviv and Kyiv.

Storms bring tornado, flood fears to eastern US

Most of the eastern U.S. faced severe weather threats Thursday as a deadly storm system that inflicted heavy damage across the Gulf Coast headed north, bringing heavy rain, strong winds and possible tornadoes to the Southeast, mid-Atlantic and Great Lakes regions.

More than 155,000 utility customers were wh power from Louisiana to North Carolina, according USA TODAY database. Airports spanning much of the eastern U.S. reported significant delays.

The most holdups occurred in Orlando, where more than 140 flights were delayed and a dozen were canceled, according to the flight tracking website FlightAware.

Tornadoes and damaging winds were among forecasters' top concerns after at least three twisters were confirmed in southern Louisiana on Wednesday. Gulf Coast residents and authorities alike were still assessing the damage after a series of powerful storms destroyed homes, uprooted trees, knocked out power to tens of thousands of homes and businesses and caused flooding, particularly in New Orleans.

Ten inches of rainfall was recorded in southeastern Texas and Louisiana, the weather service said. In Mississippi, more than 8 inches fell in the central town of Europa. Parts of Georgia, Florida and Alabama had 3-5 inches of rain.

Two confirmed tornadoes ripped through Slidell outside New Orleans, and the southwestern city of Lake Charles, where the twister had top wind speeds of 115 mph.

Another tornado was confirmed in Saint Francisville, a town northwest of Baton Rouge, according to weather service survey crews.

Damage in Saint Francisville and Slidell was consistent with at least an EF-1 tornado, which can fuel winds of 86-110 mph, the weather service said.

One person died in Mississippi due to the storms, according to state's emergency management agency. The 64-year-old woman's oxygen machine stopped working after losing power in Scott County, Weather. com reported.

In Pensacola, Florida, strong winds uprooted a massive tree and toppled it onto Robert Havens' mobile home. Just before the tree crushed the center of the trailer, Havens was able to lead his roommate, Robert Johnson, into the bathroom where they both sheltered.

"I heard like a 'snap' or 'crack' or something and I jumped up, and I walked over and I grabbed him by the arm and I said, 'Get back to here!' gripped America and divided the country largely among racial lines. But the jury in a civil trial found Simpson liable for the double murder, and he later served nine years in prison for his role in a botched armed robbery. He was granted parole in 2017.

It completed a stunning fall from grace for the oncecelebrated running back who won the Heisman Trophy in 1968 while starring at the University of Southern California. At times he looked unstoppable in the NFL, too, as a member of the Buffalo Bills who was inducted into both the College Football Hall of Fame and the Pro Football Hall of Fame.

He capitalized on his athletic success in Hollywood, developing a career as a successful actor and TV pitchman. But it all came crashing down after the murder charges that riveted America.

There was the televised low-speed car chase in 1994, with Simpson in his white Ford Bronco and police in pursuit as Los Angeles residents cheered from freeway overpasses.

There was the so-called "Trial of the Century" in 1995, when a host of high-powered figures emerged, including Johnnie Cochran, one of Simpson's defense attorneys. He turned a bloody glove found at the scene of the crime into one of the most memorable moments of the trial, saying, as Simpson struggled to put his hand in the glove, "If it doesn't fit, you must acquit."

His acquittal set off celebrations from those who pointed to historically unjust treatment of Black people by the U.S. justice system but dismay from those who argued that, regardless of race, the system favored those who could afford high-priced lawyers.

The son of Eunice Simpson and Jimmy Lee Simpson, Orenthal James Simpson was born July 9, 1947, in San Francisco and was known as "O.J." from birth.

Saddled with poor grades, the Galileo High School football star enrolled at City College of San Francisco, where he was named to the Junior College All-America team. After transferring to the University of Southern California, he led the nation in rushing during the 1967 and 1968 seasons.

"O.J. Simpson was the first player to reach a rushing mark many thought could not be attained in a 14-game season when he topped 2,000 yards," said Pro Football Hall of Fame President Jim Porter in a statement Thursday. "His on-field contributions will be preserved in the Hall's archives in Canton, Ohio."

The end of Simpson's football career marked the start of his celebrity as a broadcaster and actor. Contributing: Reuters.
