Robert Steele announced the Martin Digital History grant will be ending in December 2025, the need to continue this work, and to obtain new funding sources. He suggested that the Board send a letter of support to the Martin County BOCC. He also shared the House of Refuge restoration will start soon.

Jacqui May shared that the State has "Florida Memory" library as another possible resource for preserving MC history. Board member May requested the status of the historic county survey. She will forward the contact information of the company in St. Augustine to Jordan Pastorius and possible grant matches. Board member Steele requested the previous historic county survey and scope be provided during the next meeting in August. Board member May requested a 2024/2025 financial report be presented to the Board during the August meeting.

She announced the MC Black Heritage Initiative organization is meeting with Martin County School Board on June 17, 2025, to discuss a Memorandum of Understanding to teach living history.

Joette Lorion Rice – wants to revise the Historic Preservation presentation before it gets used again. Board member Rice asked about why the Board had not been notified about the restoration of the House of Refuge. Jordan Pastorius will research this question and speak to the appropriate staff regarding the Board's concern.

*Sherry Lee moved to have Joette Lorion Rice draft a letter of support for continuing the MC Digital History project with the intent for the Historic Preservation Board to contribute a monetary amount. **Jacqui May seconded the motion. ***Motion passed unanimously.

*Jacqui May moved to have a 2024/2025 financial report provided to the Board in August. **Sherry Lee seconded the motion. ***Motion passed unanimously.
