

The florist business placed arrangements in luxury hotels, restaurants, residences and yachts as well as dressing the windows of Gucci, Tiffany and other famous retailers along the avenue.

I worked mainly on conceptual design, drafting projects, elevations, site plans, attended site plan review meetings, zoning board meetings, drafted landscape designs and budgets, did field work such as specimen tagging for preservation during site clearing.

I developed many skills as a small business owner, from accounting and advertising to procurement and contract negotiation. Our primary function was large scale contract landscaping and interior landscaping for major commercial clients. I worked closely with architects and interior designers to coordinate installations, meet design criteria and deadlines, provide maintenance requirements, and provide commercial-grade holiday decoration as needed. I managed two locations, a staff of about 15 people and a fleet of ten trucks, The companies became valuable and well-recognized brands.

From that location I currently manage and mentor ten agents and several short-term vacation rental units.
