

**Termination of Interlocal Agreement
Palm City Elementary School East Playground**

This Termination of Interlocal Agreement Palm City Elementary School East Playground ("Termination") is made and entered into between Martin County, a political subdivision of the State of Florida by and through its Board of County Commissioners created pursuant to Art. VIII, § 1, Fla. Const. ("County"), the School Board of Martin County created pursuant to Art. IX, § 4, Fla. Const ("School Board"), and the Palm City PTA, a Florida not-for-profit corporation ("PTA"). The County, the School Board and the PTA each sometimes referred to as a "Party" and collectively as the "Parties."

WHEREAS, the County, the School Board, and the PTA entered into that certain Interlocal Agreement Palm City Elementary School East Playground dated May 21, 1991 and recorded on May 31, 1991, in Official Records Book 909, Page 873, regarding the use of the playground referred to as "Wildcat Wonderland" therein; and

WHEREAS, the County and the School Board are, or have, entered into a new interlocal agreement for the use and enjoyment of the playground at the Palm City Elementary School known or previously referred to as Wildcat Wonderland; and

WHEREAS, the Parties desire to terminate the 1991 Interlocal Agreement.

NOW, THEREFORE, in consideration of the mutual promises contained herein, it is agreed between the Parties as follows:

1. The Interlocal Agreement Palm City Elementary School East Playground, which was recorded with the Martin County Clerk of Court under the following information, is hereby terminated and of no further force or effect.
