The current roundabout at Martin Avenue will be removed and replaced with two roundabouts, one that designates the entrance to the Preserve at Rio Marine Village (north of Dixie Hwy) and one indicating the entrance to Rio Marine Village (south of Dixie Hwy).

- J. Rolle Taylor There is a blank wall off of Cove Road from 45<sup>th</sup> to 47<sup>th</sup> streets. Maybe there could be a mural or have them part of the Investment Program?
