**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MARTIN  
COUNTY, FLORIDA, RELATING TO THE EXECUTION OF A MAINTENANCE  
MEMORANDUM OF AGREEMENT FOR A MULTI-USE TRAIL ON SR-5 (US-1 / SE  
FEDERAL HIGHWAY) WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION**

**WHEREAS**, the Florida Department of Transportation (hereinafter FDOT) owns the right-of-way and has jurisdiction over State Road (hereinafter SR) 5 (US-1 / SE Federal Highway) from the Hobe Sound National Wildlife Refuge to SE Osprey Street in Martin County, Florida; and

**WHEREAS**, the FDOT will construct a Multi-Use Trail within the right-of-way of SR-5 (US-1 / SE Federal Highway) from the Hobe Sound National Wildlife Refuge to SE Osprey Street with Project Numbers 443505-1-52-01 and 448447-2-52-01; and

**WHEREAS**, the Board of County Commissioners has agreed to maintain the drainage facilities, signs, sign posts, and pavement markings necessary to support the Multi-Use Trail and to keep the Multi-Use Trail free from graffiti, residue, obstructions, and vegetation within the right-of-way of SR-5 (US-1 / SE Federal Highway).

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY, FLORIDA, THAT:**

1. The Maintenance Memorandum of Agreement for a Multi-Use Trail along SR-5 (US-1 / SE Federal Highway) in Hobe Sound, Florida is hereby approved;
2. The County Administrator, or designee, is hereby authorized to execute the Maintenance Memorandum of Agreement for a Multi-Use Trail along SR-5 (US-1 / SE Federal Highway) in Hobe Sound, Florida and future amendments and modifications to the Agreement, as necessary.
