QUASI-JUDICIAL PROCEDURES

QUASI-JUDICIAL PROCEDURES

Quasi-Judicial procedures apply when a request involves the application of a policy to a specific application and site. It is a quasi-judicial decision. Quasi-judicial proceedings must be conducted with more formality than a legislative proceeding. In quasi-judicial proceedings, parties are entitled - as a matter of due process to cross-examine witnesses, present evidence, demand that the witnesses testify under oath, and demand a decision that is based on a correct application of the law and competent substantial evidence in the record.

STAFF: Mr. Schilling polled the members regarding their expected attendance at the next probable meetings of September 18, 2025, and October 2, 2025.



The Local Planning Agency meeting of August 21, 2025, adjourned at 7:04 pm.


