Letter of Qualifications

My name is Chandler M. Josie. I am a native of Martin County growing up in Port Salerno as a second-generation Bahamian-American. My grandparents settled in the New Monrovia neighborhood in the 1920s after emigrating from the Bahamas.

I attended Port Salerno Elementary, Murray Middle School and graduated from South Fork High School in 1988. Two short months after graduation I departed the area to serve my country in the United States Army where I served faithfully and fully during the Desert Storm campaign. After my honorable discharge from the military I lived briefly in West Palm Beach before returning to Martin County (home sweet home). I lived alternately between Stuart and Port Salerno before settling as a homeowner in Port Salerno with my wife. We have been happily married for 19 years and now have 5 children ranging in age from 23 to 2 (the youngest we are court-appointed caretakers pending our confirmation of adoption).

I am a federal employee working for the Department of Veteran Affairs at the West Palm Beach Veteran Affairs Medical Center. I've worked for the VA for the past 15 years previously working for the Florida Department of Revenue, Child Support Enforcement in West Palm Beach.

I previously volunteered with the Boys & Girls Club of Martin County mentoring elementary and middle school-aged boys.
