**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF
MARTIN COUNTY, FLORIDA, RELATING TO THE ACCEPTANCE OF
SE HILLSIDE CIRCLE IN THE AMENDED PLAT OF BLOCKS 1, 2 AND 3
HOBE SOUND INTO THE COUNTY ROAD INVENTORY**

WHEREAS, the streets shown on the Amended Plat of Blocks 1, 2 and 3 Hobe Sound, according to the Plat thereof as recorded in Plat Book 10, Page 9, of the public records of Palm Beach (now Martin) County, Florida were dedicated to the perpetual use of the public; and

WHEREAS, a Road Opening Permit application was submitted to construct and open SE Hillside Circle, as shown on said Amended Plat of Blocks 1, 2 and 3 Hobe Sound; and

WHEREAS, the Board of County Commissioners has authorized staff to determine that this application complies with the requirements for opening roads as set forth in the Land Development Regulations, Martin County Code; and

WHEREAS, the County Engineer issued the Road Opening Permit numbered ENG2021080018; and

WHEREAS, the applicant has constructed the roadway improvements in full compliance with the permitted construction plans and specifications under the supervision of applicant's Engineer and the applicant's Engineer has furnished an Engineer's Certification of Construction Completion to the County Engineer for acceptance; and

WHEREAS, the Board of County Commissioners agrees to maintain the proposed road and stormwater management system within the right-of-way following a one-year maintenance period upon acceptance of the construction of the road, on-street parking, sidewalks and stormwater management system.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY, FLORIDA, THAT:

Upon the County Engineer's acceptance of the Certification of Construction Completion, the Board of County Commissioners of Martin County, Florida hereby accepts into the Martin County Road Inventory 720 linear feet, more or less, of SE Hillside Circle from SE Dixie Highway to SE Dixie Highway. The local road will be added as publicly owned and maintained within a 50-foot-wide right-of-way, having 20 feet of asphalt pavement, on-street parking on its right side, a 6-foot-wide sidewalk on both sides, a posted speed of 25 MPH, and using exfiltration trenches to manage the stormwater runoff.
