PRESENTATIONS

Agenda Item: 25-0800, CRA – Capital Projects Review

Susan Kores, CRA Director, presented the March 24, 2025, CRA Capital Projects review highlighting the following projects: Golden Gate El Camino, Port Salerno Park Drive, Port Salerno New Monrovia Park Improvements, Neighborhood Improvements, and the Unpaved Roads project.

J. Rolle-Taylor – Is the grant still pending?

S. Kores – Yes, still pending.

NEW BUSINESS

Agenda Item: 24-0803, CRA Capital Improvement Plan (CIP) Recommendations for FY 2026

Susan Kores, CRA Manager, and Stephanie Merle, Office of Management & Budget Director, provided the annual review of CRA projects and funding with detailed information on the 2026 CIP for current, continuing, and new projects for each of the six CRA areas.

C. Smith – What is the Investment Program?

S. Kores – It's a grant program for eligible property owners within a particular subdistrict that can be utilized for assistance for property improvements, such as signage, landscaping, fencing and façade improvements, etc.

J. Rolle-Taylor – We appreciate how money was added to the unpaved roads category.

S. Tsafarides – Does the Dixie Highway project include the train?

S. Kores – It includes the Train Station Plaza.

M. Readling – Does Habitat for Humanity create a conflict of interest for me?

S. Kores – No, it does not.

Agenda Item: 25-0804, CRA – Alternative Compliance

Elysse Elder, Deputy County Attorney, presented the proposed ordinance that revises the standards, criteria, and process to obtain alternative compliance in Community Redevelopment areas.

R. Krebs – How is it being delivered to us?

E. Elder – It will be part of your agenda packet a week in advance to review.

J. Rolle-Taylor – What happens if someone wants to speak about the agenda item and can't make it to the meeting?

E. Elder – They can send an email to the CRA or your County email.

G. Ehrler – On the bottom of page 28 in your packet there is a striking that is concerning. I ask that it stays in there and goes before the NAC (Neighborhood Advisory Committee). This will give more opportunity for the public to speak on it.

E. Elder – The Growth Management Director will no longer make the decision; it will be this board. Previously, he had the option to send it to the NACs if he was unsure, or if it was controversial or he wanted more information.

S. Kores – This will allow the public to have more opportunities to speak up on all the applicants. Currently, most Alternative Compliance applicants do not go to the NACs.

J. Rolle-Taylor – I like the idea of how we the Board can send it back to the NACs. Where can it be specified in the ordinance?

E. Elder – It's not in the ordinance, but it will be the Board in the decision making to hold and send it back to the NAC during their motion, if they choose to do so.

J. Pastorius – From experience, the applicants who submit for Alternative Compliance are on a timeline. Going to the NAC and the CRA Board and back and forth could be at least three months. It's wasted time on their end, which will result in a frustrated applicant.


