RESOLUTION INCREASING THE SE SALERNO ROAD RESURFACING (SCOP) GRANT REVENUES AND APPROPRIATIONS

- WHEREAS,** The Florida Department of Transportation is providing grant funding in the amount of \$657,931 for the SE Salerno Road Resurfacing (SR-76/Kanner Highway to SE Willoughby) SCOP grant and;
- WHEREAS,** Martin County is required to provide a match of \$642,690 to come from Roads MSTU fund and;
- WHEREAS,** Unanticipated funds must be appropriated in accordance with Section 129.06(2)(d), F.S.;
