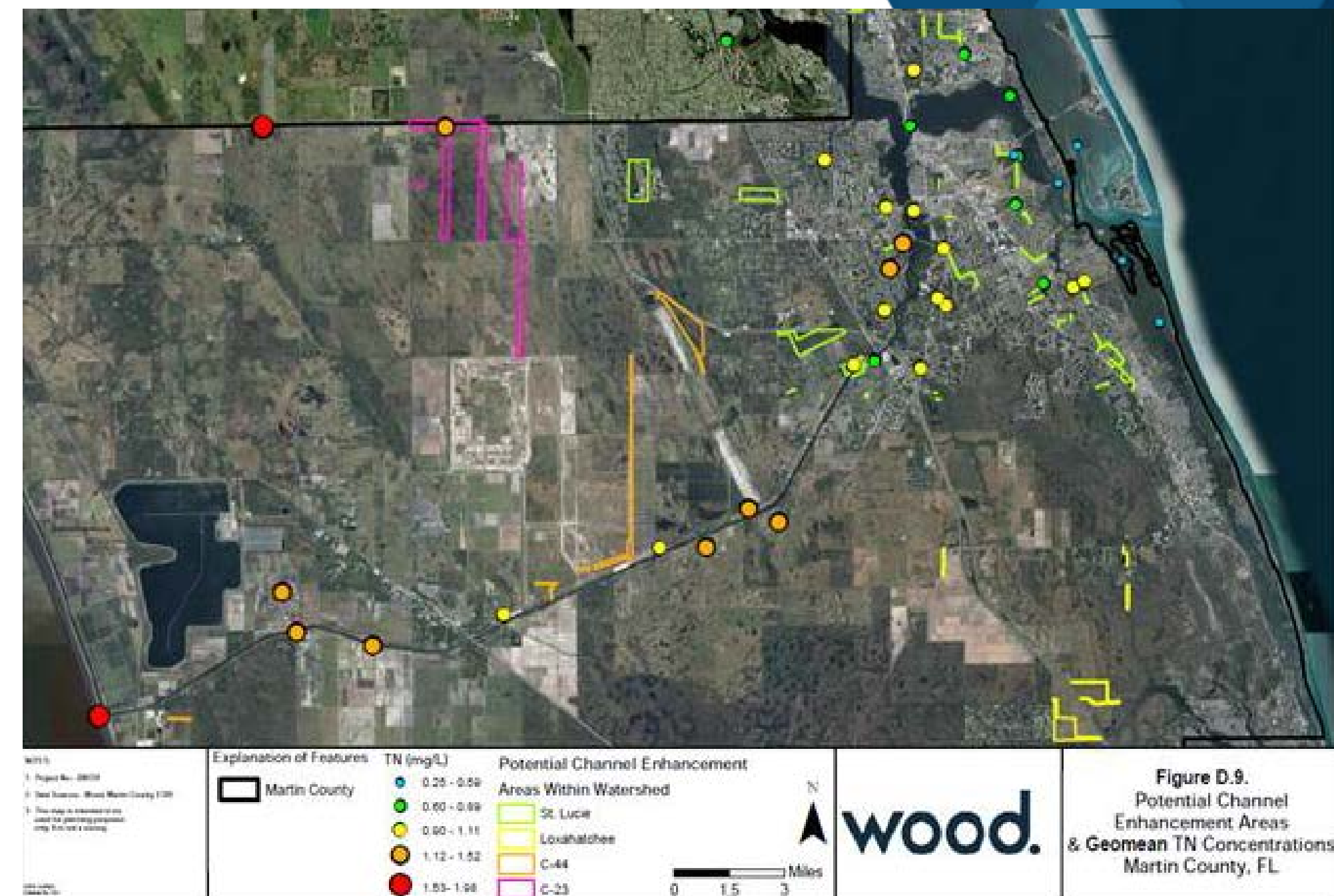
Martin County seeks to improve water quality in the St. Lucie River, Loxahatchee River, and Indian River Lagoon through new and improved stormwater infrastructure and innovative Best Management Practices. Conceptual designs have been developed for 5 Stormwater Treatment Areas (STAs) and Channel Enhancement projects.

Channel Enhancement Projects:

- ▶ 50 miles of stormwater channels within County-owned property
- ▶ Across 4 watersheds (St. Lucie, Loxahatchee, C-44, and C-23)
- ▶ Design Concept Examples:
 - Stream Restoration/Natural Channel Design
 - Forested bank slope reduction
 - Wetland rehydration
 - Soil bioengineering
 - Multi-stage channels
 - Bio-active media enhancement



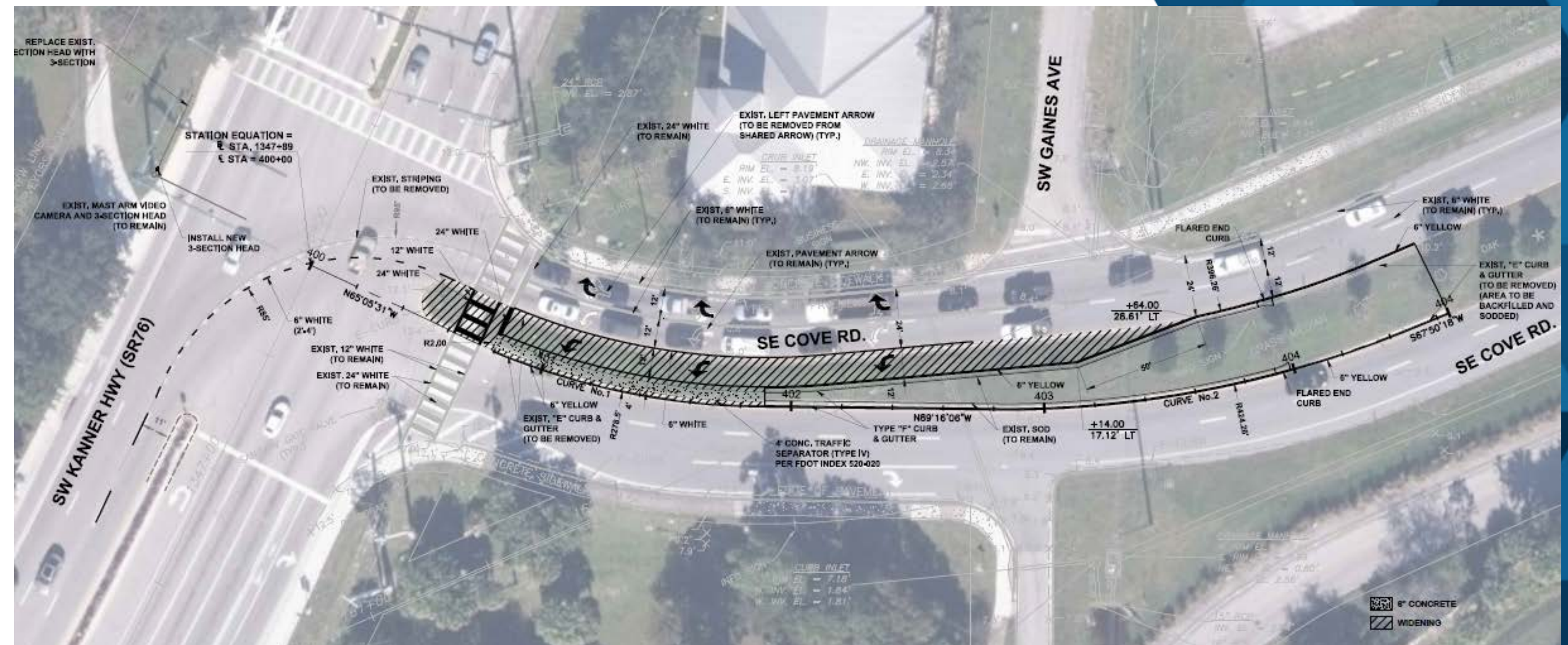

Safety & Security

Seconds Matter: Preparation and Training

- **All staff have been trained on school safety measures to include emergency procedures, classroom management during crisis incidents and active assailant response.**
- In accordance with Chapter 1006.07, Florida Statutes, the District has established threat assessment teams at each school site. Team duties include the coordination of resources, assessment and intervention for individuals whose behavior may pose a threat to the safety of staff or students.

Leading the Charge for Safe Learning Environments

- **MCSD was one of the first school districts in Florida to adopt two comprehensive systems that assist in the identifying and tracking of student whereabouts and emergency incidents.**
- Alyssa's Law (scheduled to take effect July 1, 2021, in Florida) requires districts to install silent panic alarms that are directly linked to local law enforcement, allowing first responders to arrive on the scene of an emergency as quickly as possible.
 - Through the early adoption of the Centegix CrisisAlert system (one of the first school districts in Florida), every MCSD employee has the ability to activate a location-specific or sitewide lockdown with the push of a button on their ID badge.



Safety & Security

Leading the Charge for Safe Learning Environments

- **MCSD was one of the first school districts in Florida to adopt two comprehensive systems that assist in the identifying and tracking of student whereabouts and emergency incidents.**
- The District is also one of the only school districts in Florida to have implemented the Reaxium bus ridership solution.
 - Ridership is monitored on a continuous basis using students' identification badges. Every time a student boards or exits their bus, the District can determine the pick up/drop off times and locations.
 - Reaxium system has also allowed the District to develop and maintain accurate seating charts, assisting staff with performing timely contact tracing.
 - The District is currently developing a pilot system with Reaxium that will aid in reunification during a crisis.

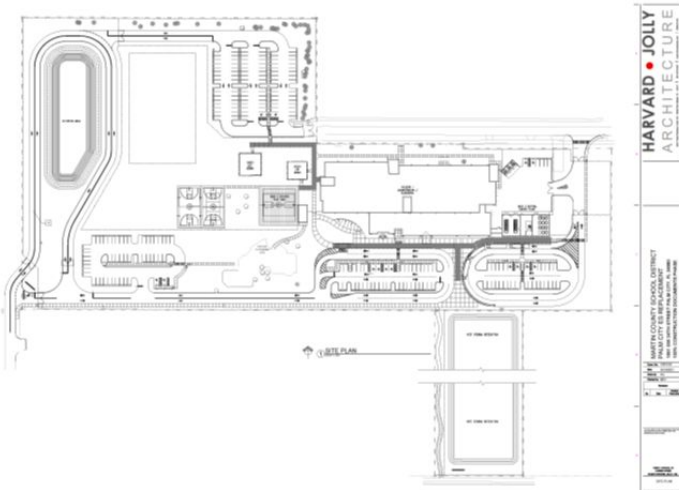

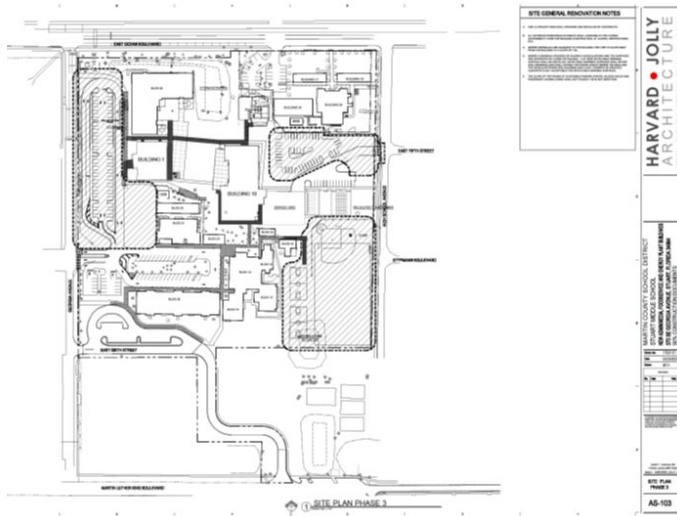

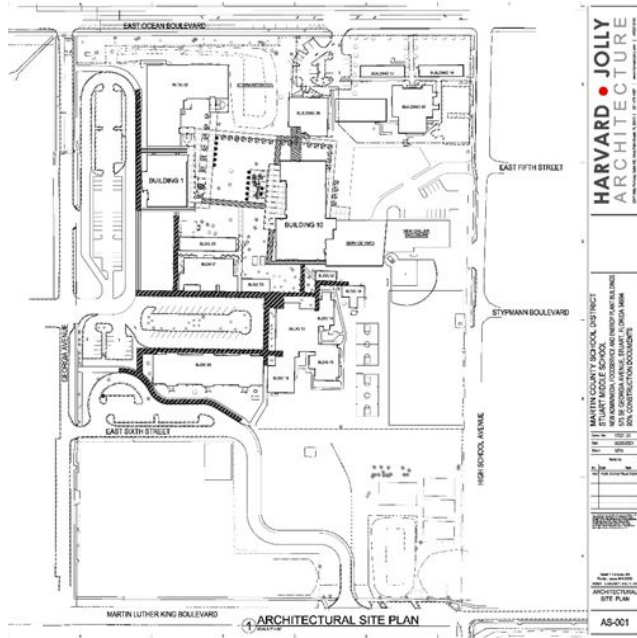

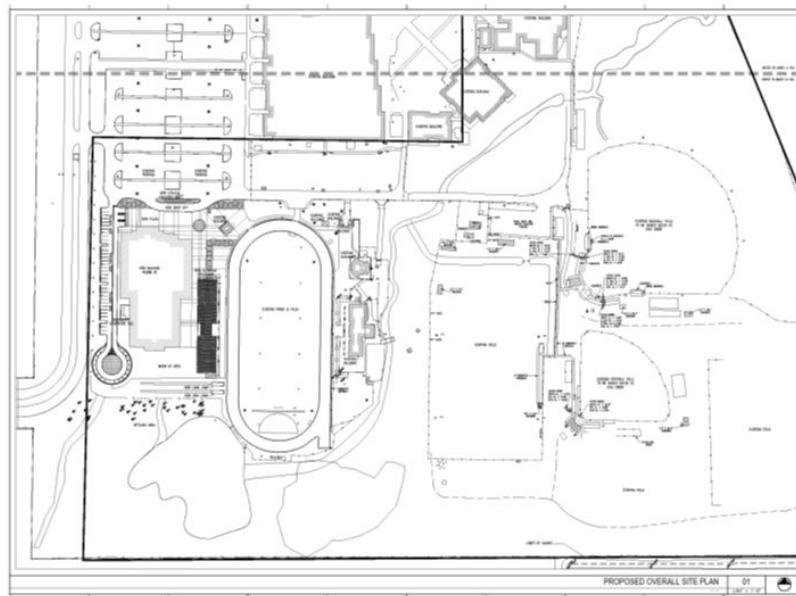

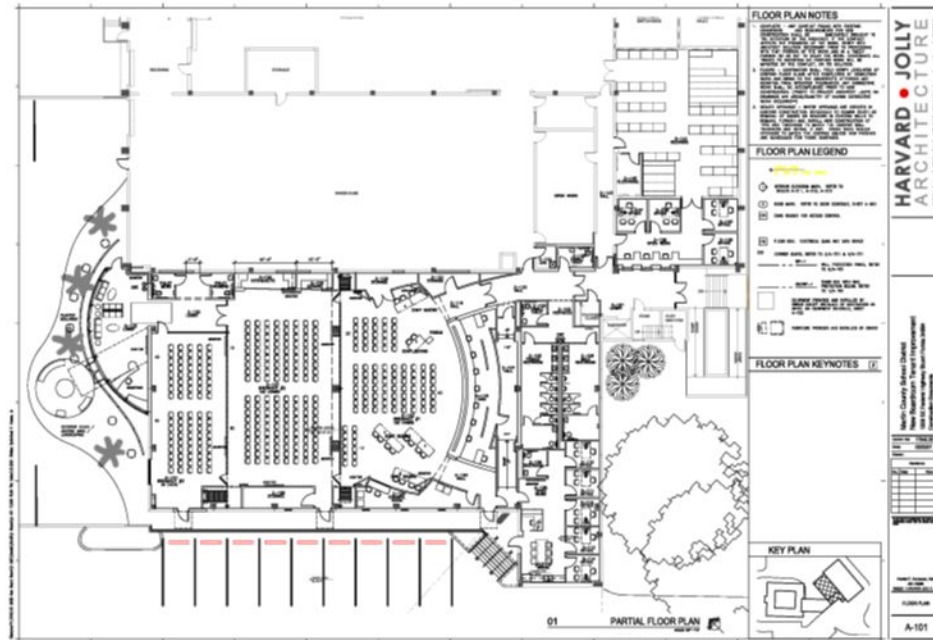

Fall/Spring Enrollment Comparison - 2020-2021 School Year

Enrollment Summary

- **Elementary schools increased** by 116 students (+1.67%).
- **Middle schools increased** by 3 students for a (+0.08%).
- **High schools decreased** by 160 students (-0.25%) attributed to mid-year promotions in January.
- **Slight decrease from the total Fall 2020 to Spring 2021 enrollment (-0.25%).**
- Enrollment is based on COFTE – (Capital Outlay Full-Time Equivalency)

Back to School 21-22

- **In August 2021, the District will make a full return to traditional, in-person learning.** All students attending a District-operated school will attend classes on campus each day. Florida Virtual School remains an option for families wanting a non-traditional alternative.
- **The Florida Department of Education (FDOE) has recommended that masks be voluntary for the 2021-2022 school year. Barring an unusually high spike in positive COVID-19 cases or change in pandemic circumstances, the District plans to follow this recommendation.**
 - As the District begins planning for the 2021-2022 school year during the summer months, recommendations from the Florida Department of Health in Martin County (DOH Martin) and the District's Pandemic Crisis Response Team will be shared with the School Board.



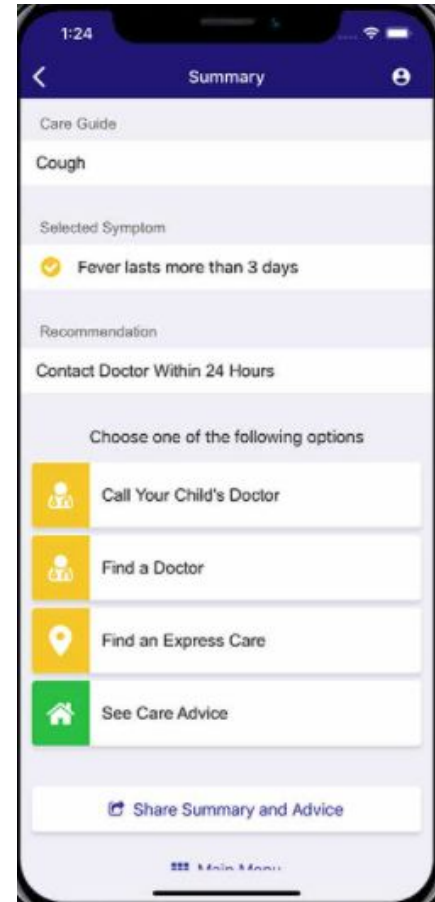
Back to School 21-22

- **Social distancing will be practiced to the greatest extent possible.** The District will make every effort to provide increased physical distancing between students (including placing desks 3-6 ft. apart as recommended by grade level).
- **Limiting Capacity.** Events may require limited capacity based on the type of activity and the expected number of attendees. All indoor spaces will continue to be cleaned and disinfected frequently.
- **Maintaining Healthy Facilities.** Surfaces will continue to be cleaned and sanitized using EPA-registered disinfectants. Facilities have been outfitted with either MERV 10 or MERV 13 filters for increased filtration.



Back to School 21-22

- **Monitoring Symptoms.** Students and employees are encouraged to protect their own health and the health of those around them by monitoring their symptoms daily and staying home when sick. **The District will be unveiling a new digital symptom checker to aid students and staff in making decisions about their health.** The tool will be accessible on the District's website and via the App Store and Google Play.
- **Vaccines Encouraged.** The CDC and DOH advise that the COVID-19 vaccine is the best, long-term way to combat the virus. **In accordance with Florida DOH policies, staff and students who have been fully vaccinated will not be required to quarantine after contact with a positive case.**



Back to School 21-22

- **Staying Informed.** As part of its commitment to timely, transparent and reliable communication, the District will unveil a new website and mobile app this summer. These refreshed resources will provide families, employees and members of the community with convenient “one-stop-shops” to find important information about our schools, programs and initiatives.
